İ WHEREAS. pursuant to Article IX. Section 7 of the Constitution of the Tohono O'odham 2 Nation. 3 No district council shall expend district funds except pursuant to budgets 4 authorized under resolutions of the district council and approved by the 5 Tohono O'odham Council. The management of these funds shall be only by 6 a treasurer or other authorized officer of the district council who has 7 furnished a surety bond satisfactory to the treasurer of the Tohono 8 O'odham Nation, and all expenditures of these funds shall be by checks 9 signed by such treasurer or other authorized officer and the chairman or 10 vice chairman of the district council. 11 ; and 12 WHEREAS, by Gu Achi District Council Resolution No. 1120-149 the Gu Achi District has 13 authorized the Gu Achi District Tower User Funds Budget, which is incorporated 14 by this reference, in the amount of \$231,739.95 to be funded by Tower User Fees 15 revenues: and 16 WHEREAS. the Budget and Finance Committee has reviewed the FY 2021 Gu Achi District 17 Tower User Funds Budget and recommends approval. 18 19

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the FY 2021 Gu Achi District Tower User Funds Budget effective November 9, 2020 in the amount of \$231,739.95 that shall be funded by Tower User Fees revenues.

BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the FY 2021 Gu Achi District Tower User Funds Budget shall be managed and expended in accordance with Article IX, Section 7 of the Constitution of the Tohono O'odham Nation and the Nation's laws, provided that any amendments or modifications shall be authorized under District Council resolution and submitted for prior approval by the Tohono O'odham Legislative Council.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05^{TH} day of JANUARY, 2021 at a meeting at which a quorum was present with a vote of 3,175,7 FOR: -0-AGAINST; _Q_ NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
