8		States Coronavirus Relief Fund ("Relief Fund") as approved by the Coronavirus
9	:	Aid, Relief, and Economic Security Act ("CARES Act"); and
10	WHEREAS,	the FY 2021 Tohono O'odham Nation Coronavirus Relief Fund Budget in the
11		amount of \$61,115,398.00 was approved by Legislative Council Resolution No. 20-
12		226 for the period of March 1, 2020 to December 30, 2020; and
13	WHEREAS,	Congress extended the federal deadline for expending the Coronavirus Relief
14		Fund to December 31, 2021; and
15	WHEREAS,	the Executive Branch has prepared and submitted for review and approval its FY
16		2021 Tohono O'odham Nation Coronavirus Relief Fund Budget Amendment No. 1,
17		which is incorporated by this reference and which will adjust operational and/or
18		personnel line items; and
19	WHEREAS,	the FY 2021 Tohono O'odham Nation Coronavirus Relief Fund Budget
20		Amendment No. 1 will not change the original budget amount of \$61,115,398.00;

22	WHEREAS,	the Budget and Finance and Appropriations Committees recommend amending
23		the FY 2021 Tohono O'odham Nation Coronavirus Relief Fund Budget to extend it
24		through December 31, 2021; and
25	WHEREAS,	the Budget and Finance Committee reviewed the FY 2021 Tohono O'odham Nation
26	•	Coronavirus Relief Fund Budget Amendment No. 1 and recommends approval.
27	NOW, THERE	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council:
28		1. amends the FY 2021 Tohono O'odham Nation Coronavirus Relief Fund
29		Budget to extend the effective dates from March 1, 2020 to December 31,
