

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending FY 2021 Tohono O'odham Nation Coronavirus Relief Fund Budget
to Extend Time Period and Approving Budget Amendment No. 1)**

RESOLUTION NO. 21-018

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS** the Tohono O'odham Nation ("Nation") received \$61,115,398.00 from the United
8 States Coronavirus Relief Fund ("Relief Fund") as approved by the Coronavirus
9 Aid, Relief, and Economic Security Act ("CARES Act"); and

10 **WHEREAS,** the FY 2021 Tohono O'odham Nation Coronavirus Relief Fund Budget in the
11 amount of \$61,115,398.00 was approved by Legislative Council Resolution No. 20-
12 226 for the period of March 1, 2020 to December 30, 2020; and

13 **WHEREAS,** Congress extended the federal deadline for expending the Coronavirus Relief
14 Fund to December 31, 2021; and

15 **WHEREAS,** the Executive Branch has prepared and submitted for review and approval its FY
16 2021 Tohono O'odham Nation Coronavirus Relief Fund Budget Amendment No. 1,
17 which is incorporated by this reference and which will adjust operational and/or
18 personnel line items; and

19 **WHEREAS,** the FY 2021 Tohono O'odham Nation Coronavirus Relief Fund Budget
20 Amendment No. 1 will not change the original budget amount of \$61,115,398.00;
21 and

22 **WHEREAS,** the Budget and Finance and Appropriations Committees recommend amending
23 the FY 2021 Tohono O'odham Nation Coronavirus Relief Fund Budget to extend it
24 through December 31, 2021; and

25 **WHEREAS,** the Budget and Finance Committee reviewed the FY 2021 Tohono O'odham Nation
26 Coronavirus Relief Fund Budget Amendment No. 1 and recommends approval.

27 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council:

- 28 1. amends the FY 2021 Tohono O'odham Nation Coronavirus Relief Fund
29 Budget to extend the effective dates from March 1, 2020 to December 31,
30 2021 which shall be funded by the CARES Act Coronavirus Relief Fund; and
 - 31 2. approves the FY 2021 Tohono O'odham Nation Coronavirus Relief Fund
32 Budget Amendment No. 1 effective March 1, 2020 to December 31, 2021,
33 which will not change the original budget amount of \$61,115,398.00.

1 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
2 Nation chairperson or any designated official is authorized to administer and
3 expend the FY 2021 Tohono O'odham Nation Coronavirus Relief Fund Budget as
4 amended, provided that any amendments or modifications shall be submitted
5 for prior approval by the Tohono O'odham Legislative Council.

6 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05TH
7 day of JANUARY, 2021 at a meeting at which a quorum was present with a vote of 3,175.7 FOR; -0-
8 AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by
9 Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by
10 the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
11 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
12 18, 1934 (48 Stat.984).
