

LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Setting January 13, 2021 Special Session for a Presentation by the Bureau of Indian Education)

LEGISLATIVE ORDER NO. 21-020

1 **WHEREAS, the Legislative Council is vested with the power "to establish rules and**
2 **procedures to regulate all meetings of the Tohono O'odham Council, standing**
3 **committees, boards and special committees." (Constitution of the Tohono**
4 **O'odham Nation, Article VI, Section 1(a)); and**

5 **WHEREAS, the Legislative Rules of the Tohono O'odham Legislative Council vests the Council**
6 **with the authority to "by majority vote, call for a special session." (Legislative**
7 **Rules of the Tohono O'odham Legislative Council, Article I, Section 1(D)(1)); and**

8 **WHEREAS, the Human Resources Development Committee has requested a special session**
9 **on January 13, 2021 for a presentation by the Bureau of Indian Education.**

10 **NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that it sets a**
11 **special session on January 13, 2021 for a presentation by the Bureau of Indian**
12 **Education.**

13 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 06TH day of**
14 **JANUARY 2021 at a meeting at which a quorum was present with a vote of 3,175.7 FOR;**
15 **-0- AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
16 **Article VI, Section 1a of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
17 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
18 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934**
