1 WHEREAS. pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham 2 Nation. 3 No district council shall expend district funds except pursuant to budgets 4 authorized under resolutions of the district council and approved by the 5 Tohono O'odham Council. The management of these funds shall be only 6 by a treasurer or other authorized officer of the district council who has 7 furnished a surety bond satisfactory to the treasurer of the Tohono 8 O'odham Nation, and all expenditures of these funds shall be by checks 9 signed by such treasurer or other authorized officer and the chairman or 10 vice chairman of the district council. 11 : and 12 WHEREAS, the FY 2021 Schuk Toak District Budget in the amount of \$3,074,043,86 was 13 authorized by Schuk Toak District Council Resolution No. ST-08-12-20-052 and 14 approved by Legislative Council Resolution No. 20-333; and 15 WHEREAS. by Schuk Toak District Council Resolution No. ST-12-12-20-87, the Schuk Toak 16 District has authorized and submitted for review and approval its FY 2021 Schuk 17 Toak District Administration Budget Amendment No. 1, which is incorporated by 18 this reference and which will adjust operational and/or personnel line items; and 19 WHEREAS. the FY 2021 Schuk Toak District Administration Budget Amendment No. 1 will not 20 change the total FY 2021 Schuk Toak District Budget amount of \$3,074,043.86; and 21 WHEREAS, the Budget and Finance Committee has reviewed the FY 2021 Schuk Toak District 22 Administration Budget Amendment No. 1 and recommends its approval. 23 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the 24 FY 2021 Schuk Toak District Administration Budget Amendment No. 1, effective 25 October 1, 2020, which does not change the total budget amount of \$3,074,043.86. 26 BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the FY 2021 Schuk 27 Toak District Budget as amended shall be managed and expended in accordance 28 with Article IX, Section 7 of the Constitution of the Tohono O'odham Nation and 29 the Nation's laws, provided that any amendments or modifications shall be 30 authorized under District Council resolution and submitted for prior approval by 31 the Tohono O'odham Legislative Council. 32
