13		authorized by Baboquivari District Council Resolution No. 2020-B-75 and
14		approved by Legislative Council Resolution No. 20-315; and
15	WHEREAS,	by Baboquivari District Council by Resolution No. 2020-B-113, the Baboquivari
16		District has prepared and submitted for review and approval its FY 2021 Cold
17		Fields Community Budget Amendment No. 1, which is incorporated by this
18		reference and which will amend the justification in Line Item No. 7035 Building
19		Materials to add new language; and
20	WHEREAS,	the FY 2021 Baboquivari District Cold Fields Community Budget Amendment No.1
21		will not change the FY 2021 Baboquivari District Budget; and
22	WHEREAS,	the Budget and Finance Committee has reviewed the FY 2021 Baboquivari District
23		Cold Fields Community Budget Amendment No. 1 and recommends its approval.
24	NOW, THERE	EFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves FY
