

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Supporting State Legislation Consistent with 2021 Gaming Compact Amendments)**

RESOLUTION NO. 21-028

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to "consult,**
2 **negotiate and conclude agreements and contracts on behalf of the Tohono**
3 **O'odham Nation with Federal, State and local governments and other Indian**
4 **tribes or their departments, agencies, or political subdivisions, or with private**
5 **persons or organizations on all matters within the authority of the Tohono**
6 **O'odham Council" (Constitution of the Tohono O'odham Nation, Article VI,**
7 **Section 1(f)); and**

8 **WHEREAS, by Resolution No. 02-562, the Tohono O'odham Nation approved and authorized**
9 **the Nation's chairman to enter into the Tohono O'odham Nation-State of Arizona**
10 **Gaming Compact (the "2003 Gaming Compact"); and**

11 **WHEREAS, the Legislative Council has authorized the Nation's chairperson and members of**
12 **the Legislative Commerce Committee to serve on the Tohono O'odham Nation**
13 **Gaming Negotiating Committee ("Gaming Negotiating Committee") in order to**
14 **negotiate gaming compact amendments or a new gaming compact with the State**
15 **of Arizona; and**

16 **WHEREAS, consistent with the Nation's Constitution and laws, voter-approved Proposition**
17 **202, and the 2003 Gaming Compact, the Gaming Negotiating Committee has**
18 **negotiated the 2021 Gaming Compact Amendments; and**

19 **WHEREAS, the State of Arizona is proposing legislation to change state law by authorizing**
20 **limited event wagering, fantasy sports, lottery, and creating an intertribal trust**
21 **fund (the "Bill") consistent with the 2021 Gaming Compact Amendments; and**

22 **WHEREAS, the Gaming Negotiating Committee has recommended to the Legislative Council**
23 **that the Nation support the Bill in its current form.**

24 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that the Tohono**
25 **O'odham Nation supports the Bill**

26 **(1) subject the execution and approval of the 2021 Gaming Compact**
27 **Amendments;**

28 **(2) provided that the off-reservation gaming authorized by the Bill shall be**
29 **strictly limited to the scope, nature and location of the activities included**
30 **in the draft presented to the Legislative Council and without further**
31 **expansion of gaming, including but not limited to expansion that would**
32 **authorize historic racing machines, racinos, or other new gaming; and**

(3) further provided that the Gaming Negotiating Committee shall regularly update the Council on the status of the 2021 Gaming Compact Amendments and the Bill or any related legislation.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21ST day of JANUARY, 2021 at a meeting at which a quorum was present with a vote of 3,175.7 FOR; -0- AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).
