

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving Additions to the Master List for the 2020 Non-Gaming Per Capita  
Distribution for Eligible Tohono O'odham Minor Members)**

**RESOLUTION NO. 21-042**

1 **WHEREAS,** the Constitution of the Tohono O'odham Nation vests the Tohono O'odham  
2 Legislative Council with the power to "manage any funds within the exclusive  
3 control of the Tohono O'odham Nation, including proceeds derived from lands  
4 and resources of the Tohono O'odham Nation, and to appropriate these funds for  
5 the benefit of the nation and its members" (Constitution, Article VI, Section  
6 1(d)(2)); and

7 **WHEREAS,** the Legislative Council adopted the 2020 Non-Gaming Per Capita Plan by  
8 Legislative Council Resolution No. 20-070 to govern a one-time non-gaming  
9 revenue per capita distribution to Eligible Members of the Tohono O'odham  
10 Nation; and

11 **WHEREAS,** by Resolution No. 21-006, the Tohono O'odham Legislative Council approved the  
12 Master List for the 2020 Non-Gaming Per Capita Distribution for Eligible Tohono  
13 O'odham Minor Members and approved the total number of verified Eligible  
14 Tohono O'odham Minor Members for the 2020 Non-Gaming Per Capita as 10,209  
15 members; and

16 **WHEREAS,** the Tohono O'odham Membership Services Enrollment Program has identified  
17 03 Minor Members who were left off the Master List for the 2020 Non-Gaming Per  
18 Capita and has identified the additional Minor Members in the February 2021  
19 Certification Listing of Minor Members for the Non-Gaming Per Capita  
20 Distribution, which is incorporated by this reference; and

21 **WHEREAS,** Tohono O'odham Membership Services has prepared and submitted to the  
22 Tohono O'odham Legislative Council the additions to the Master List for Eligible  
23 Tohono O'odham Minor Members for review and approval for the 2020 Non-  
24 Gaming Per Capita Distribution; and

25 **WHEREAS,** the total number of Eligible Tohono O'odham Minor Members for the 2020 Non-  
26 Gaming Per Capita is 10,212 members; and

27 **WHEREAS,** the disbursement of funds to each Eligible Tohono O'odham Minor Member is  
28 contingent upon verification of a member and further certification by the Tohono  
29 O'odham Legislative Council; and

30 **WHEREAS,** the Rules Committee has reviewed the Additions to the Master List for the 2020  
31 Non-Gaming Per Capita Distribution for Eligible Tohono O'odham Minor  
32 Members and recommends its approval.


1 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
2 **Additions to the Master List for the 2020 Non-Gaming Per Capita Distribution for**  
3 **Eligible Tohono O'odham Minor Members for use by Membership Services in the**  
4 **administration of the 2020 Non-Gaming Per Capita Plan provided that:**

- 5 (1) **Disbursement of the 2020 Non-Gaming Per Capita payment to each**  
6 **Eligible Tohono O'odham Minor Member is contingent upon verification**  
7 **of a member's eligibility and further certification by the Tohono O'odham**  
8 **Legislative Council.**
- 9 (2) **Approval of the Master List shall not constitute the enrollment of any**  
10 **person that is not otherwise duly enrolled in accordance with the**  
11 **Constitution and laws of the Tohono O'odham Nation.**
- 12 (3) **The Master List may be corrected by resolution of the Tohono O'odham**  
13 **Legislative Council.**

14 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council approves and**  
15 **authorizes the Office of the Treasurer to transfer \$3,000.00 from the Non-Gaming**  
16 **Per Capita Account held at Bank of America Private Bank to Principal Financial**  
17 **Group for establishment of minors accounts in accordance with the Non-Gaming**  
18 **Per Capita Plan, and pursuant to the terms of the Trust Agreement and Service**  
19 **Agreement as amended by the Tohono O'odham Legislative Council Resolution**  
20 **No. 20-402.**

21 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09<sup>TH</sup>**  
22 **day of FEBRUARY, 2021 at a meeting at which a quorum was present with a vote of 3,175.7 FOR;**  
23 **-0- AGAINST; -0- NOT VOTING; and -0- ABSENT, pursuant to the powers vested in the Council by**  
24 **Article VI, Section 1 (d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the**  
25 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
26 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
27 **18, 1934 (48 Stat.984).**
