

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2021 Sif-Oidak District Carry Forward Novel Coronavirus (COVID-19)
Community Budget Amendment No. 1 and FY 2021 Sif-Oidak District Carry
Forward Remaining Allocation Community Budget Amendment No. 1)**

RESOLUTION NO. 21-044

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham
2 Nation,

3 No district council shall expend district funds except pursuant to budgets
4 authorized under resolutions of the district council and approved by the
5 Tohono O'odham Council. The management of these funds shall be only by
6 a treasurer or other authorized officer of the district council who has
7 furnished a surety bond satisfactory to the treasurer of the Tohono
8 O'odham Nation, and all expenditures of these funds shall be by checks
9 signed by such treasurer or other authorized officer and the chairman or
10 vice chairman of the district council.

12 **WHEREAS,** the FY 2021 Sif-Oidak District Carry Forward Novel Coronavirus (COVID-19)
13 Community Budget in the amount of \$388,057.60 was authorized by Sif-Oidak
14 District Council Resolution No. SODC 20-109 and approved by Legislative Council
15 Resolution No. 20-396; and

16 **WHEREAS,** by Sif-Oidak District Council Resolution No. SODC 21-036, the Sif-Oidak District
17 has authorized and submitted for review and approval the FY 2021 Sif-Oidak
18 District Carry Forward Novel Coronavirus (COVID-19) Community Budget
19 Amendment No. 1, which is incorporated by this reference, and which will adjust
20 operational and/or personnel line items; and

21 **WHEREAS,** the FY 2021 Sif-Oidak District Carry Forward Novel Coronavirus (COVID-19)
22 Community Budget Amendment No. 1 will increase the FY 2021 Sif-Oidak District
23 Carry Forward Novel Coronavirus (COVID-19) Community Budget by \$266,865.34
24 from \$388,057.60 to \$654,922.94; and

25 **WHEREAS,** the FY 2021 Sif-Oidak District Carry Forward Remaining Allocation Community
26 Budget in the amount of \$241,776.85 was authorized by Sif-Oidak District Council
27 Resolution No. SODC 20-110 and approved by Legislative Council Resolution No.
28 20-398; and

29 **WHEREAS,** by Sif-Oidak District Council Resolution No. SODC 21-038, the Sif-Oidak District
30 has authorized and submitted for review and approval the FY 2021 Sif-Oidak
31 District Carry Forward Remaining Allocation Community Budget Amendment No.
32 1, which is incorporated by these reference, and which will adjust operational
33 and/or personnel line items; and

4 **\$241,776.85 to \$317,774.39; and**

5 **WHEREAS, the Budget and Finance Committee has reviewed the FY 2021 Sif-Oidak District**
6 **Carry Forward Novel Coronavirus (COVID-19) Community Budget Amendment**
7 **No. 1 and the FY 2021 Sif-Oidak District Carry Forward Remaining Allocation**
8 **Community Budget Amendment No. 1 and recommends their approval.**

9 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves:**

10 (1) **FY 2021 Sif-Oidak District Carry Forward Novel Coronavirus (COVID-19)**
11 **Community Budget Amendment No. 1, which includes a \$266,865.34 increase**
12 **from \$388,057.60 to \$654,922.94, effective October 1, 2020, which shall be funded**
13 **from the FY 2019 Sif-Oidak District Closeout Budgets; and**

14 (2) **FY 2021 Sif-Oidak District Carry Forward Remaining Allocation**
15 **Community Budget Amendment No. 1, which includes a \$75,997.54 increase from**
16 **\$241,776.85 to \$317,774.39, effective October 1, 2020, which shall be funded from**
17 **the FY 2019 Sif-Oidak District Closeout Budgets.**

18 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the FY 2021 Sif-Oidak**
19 **District Carry Forward Novel Coronavirus (COVID-19) Community Budget**
20 **Amendment No. 1 and the FY 2021 Sif-Oidak District Carry Forward Remaining**
21 **Allocation Community Budget Amendment No. 1 shall be managed and expended**
22 **in accordance with Article IX, Section 7 of the Constitution of the Tohono**
23 **O'odham Nation and the Nation's laws, provided that any amendments or**
24 **modifications shall be authorized under District Council resolution and**
25 **submitted for prior approval by the Tohono O'odham Legislative Council.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09TH**
27 **day of FEBRUARY, 2021 at a meeting at which a quorum was present with a vote of 3,057.9 FOR;**
28 **117.8 AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council**
29 **by Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the**
30 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
31 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
32 **18, 1934 (48 Stat.984).**
