

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2021 Planning and Economic Development Roads Program PIR 400(1)
San Lucy Design Street Lights and Sidewalks Project Budget)**

RESOLUTION NO. 21-052

1 **WHEREAS,** **the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS,** **by Resolution No. 16-346, the Legislative Council approved the FY 2017 Planning**
8 **and Economic Development Department, Roads Program San Lucy Community**
9 **Design and Construction of Sidewalks and Street Lights Budget in the amount of**
10 **\$186,020.29 to be funded by the Nation's general fund pending reimbursement by**
11 **the grantor, the Bureau of Indian Affairs; and**

12 **WHEREAS,** **the Bureau of Indian Affairs Western Region Office awarded the Nation a no- cost**
13 **extension for the design, construction of PIR 400(1) San Lucy Design Street Lights**
14 **and Sidewalks Project to September 30, 2021; and**

15 **WHEREAS,** **the Planning and Economic Development Department has prepared and**
16 **submitted for review and approval its FY 2021 Roads Program PIR 400(1) San Lucy**
17 **Design Street Lights and Sidewalks Project Budget, which is incorporated by this**
18 **reference, in the amount of \$117,174.68 that shall be funded by the Nation's**
19 **general fund pending reimbursement by the grantor, the Bureau of Indian**
20 **Affairs; and**

21 **WHEREAS,** **the Agricultural and Natural Resources and Budget and Finance Committees**
22 **have reviewed the FY 2021 Planning and Economic Development Department**
23 **Roads Program PIR 400(1) San Lucy Design Street Lights and Sidewalks Project**
24 **Budget and recommend its approval.**

25 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
26 **FY 2021 Planning and Economic Development Department Roads Program PIR**
27 **400(1) San Lucy Design Street Lights and Sidewalks Project Budget effective**
28 **October 1, 2020 through September 30, 2021 in the amount of \$117,174.68, which**
29 **shall be funded by the Nation's general fund pending reimbursement by the**
30 **grantor, the Bureau of Indian Affairs as referenced in BIAWRO Master Contract**
31 **A10AV00193.**

32 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
33 **Nation chairperson or any designated official is authorized to administer and**
34 **expend the FY 2021 Planning and Economic Development Department Roads**
