2		Legislative Council with the power "to manage any funds within the exclusive
3		control of the Tohono O'odham Nation, including proceeds derived from lands
4		and resources of the Tohono O'odham Nation" (Constitution, Article VI, Section
5		1(d)(2)); and
6	WHEREAS,	on March 5, 2020, by Legislative Council Resolution No. 20-070, the Nation
7		adopted the 2020 Tohono O'odham Nation Non-Gaming Per Capita Plan; and
8	WHEREAS,	because of the current COVID-19 pandemic, the Nation has faced significant
9		delays in processing the membership verification forms received from O'odham
10		members due to limited staff work schedules; and
11	WHEREAS,	also because the COVID-19 pandemic, there are reports of limited notary
12		services; and
13	WHEREAS,	these issues have delayed the process with the first payment not occurring until
14		September 30, 2020; and
15	WHEREAS,	the Non-Gaming Per Capita working group recommends that the 2020 Tohono
16		O'odham Nation Non-Gaming Per Capita Plan be amended to extend the date for
17		O'odham members to complete all requirements for receiving a per capita to
18		September 30, 2021; and
19	WHEREAS,	the Rules and Budget and Finance Committees, and the Nation's Chairperson
20		have reviewed the proposed amendment to the 2020 Tohono O'odham Nation
21		Non-Gaming Per Capita Plan and recommend its approval.
22	NOW, THERE	FORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it amends
23		section VIII (1) of the 2020 Tohono O'odham Nation Non-Gaming Per Capita Plan
24		to extend the date to complete all requirements for receiving a per capita to
