6		Nation, Article VI, Section 1(d)(2)); and
7	WHEREAS,	the Legislative Council is further vested with the power to "consult, negotiate and
8		conclude agreements and contracts on behalf of the Tohono O'odham Nation
9		with Federal, State and local governments or with private persons or
10		organizations on all matters within the authority of the Tohono O'odham
11		Council" (Constitution of the Tohono O'odham Nation, Article VI, Section 1(f); and
12	WHEREAS,	by Resolution No. 20-222, the Legislative Council approved a Memorandum of
13		Understanding between the Tohono O'odham Nation, Department of Health and
14		Human Services and the Arizona Board of Regents, University of Arizona, for its
15		College of Agriculture & Life Sciences, Department of Entomology and Insect
16		Science for a term coinciding with the grant period beginning July 1, 2019-June
17		30, 2021 (hereafter, referred to as "MOU"); and
18	WHEREAS,	the Department of Health and Human Services has prepared and submitted for
19		review and approval its FY 2021 Division of Community Health Services Haury
20		Grant Project Budget, which is incorporated by this reference, in the amount of
21		\$39,050.00 to be funded by the Agnese N. Haury Seed Grant; Arizona Board of
22		Regents, University of Arizona, College of Agriculture & Life Sciences, Department
23		of Entomology and Insect Sciences for a term beginning July 1, 2020 - December
24		31, 2021; and
25	WHEREAS,	the University of Arizona Haury Program agreed to a no-cost extension of the
26		grant period for a new project completion date of December 31, 2021; and
27	WHEREAS,	Amendment No. 1 to the MOU reflects the no-cost extension of the grant period
28		date to December 31, 2021; and
29	WHEREAS,	the Health and Human Services and Budget and Finance Committees have
30		reviewed the FY 2021 Department of Health and Human Services Division of
31		Community Health Services Haury Grant Project Budget and Amendment No. 1 to
