

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2021 Pisinemo District Communities and Operations Chart of Budgets)**

RESOLUTION NO. 21-058

WHEREAS, pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham Nation,

No district council shall expend district funds except pursuant to budgets authorized under resolutions of the district council and approved by the Tohono O'odham Council. The management of these funds shall be only by a treasurer or other authorized officer of the district council who has furnished a surety bond satisfactory to the treasurer of the Tohono O'odham Nation, and all expenditures of these funds shall be by checks signed by such treasurer or other authorized officer and the chairman or vice chairman of the district council.

WHEREAS, by Pisinemo District Council resolutions, the Pisinemo District has authorized and submitted for review and approval its FY 2021 Pisinemo District Communities and Operations Budgets, effective October 1, 2020 and January 7, 2021, as identified in the FY 2021 Pisinemo District Chart of Budgets below and which is incorporated by this reference, and which budgets shall be funded in the amounts and by funding sources identified in the FY 2021 Pisinemo District Communities and Operations Chart of Budgets as follows:
