1	WHEREAS,	the Tohono O'odham Nation is a sovereign and federally recognized Indian tribe
2		possessing powers of self-government and sovereign immunity; and
3	WHEREAS,	the Nation's sovereign immunity extends to its 11 local district governments, and
4	Ī	a district's immunity may not be waived "except by a resolution or other official
5	!	action of the Tohono O'odham Legislative Council expressly waiving, or
6		authorizing a waiver of, sovereign immunity" 1 Tohono O'odham Code Chapter 2,
7		Section 2101(B) and (C); Juan v. Juan, 2 TOR3d 62 (Trial Ct., Jan. 27, 2000) appeal
8		dism'd, 3 TOR 3d 1 (Jan. 4, 2005); and
9	WHEREAS,	the San Xavier District applied for and received grant funds from the Department
10		of Energy to construct two Solar PV Systems in the San Xavier District; and
11	WHEREAS,	a Construction Services Agreement (hereafter, "Agreement") between the San
12		Xavier District and RDS DEVCO, LLC, which is incorporated by this reference,
13		states that the Tohono O'odham Nation has authorized a limited waiver of San
14		Xavier District's sovereign immunity and that the San Xavier District consents to
15		be sued to enforce arbitration or an arbitration award; and
16	WHEREAS,	paragraph 34(i) of the Agreement further states that the San Xavier District is not
17		waiving its right, or that of the Nation, to assert the defense of sovereign immunity
18		except as expressly set forth, referred to, and provided for, in the Agreement; and
19	WHEREAS,	the Commerce Committee has reviewed the limited waiver of sovereign
20		$immunity\ within\ the\ Agreement\ between\ the\ San\ Xavier\ District\ and\ RDS\ DEVCO,$
21		LLC, and recommends its authorization.
22	NOW, THERE	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council authorizes
23		the limited waiver of sovereign immunity contained within the Construction
24		Services Agreement between the San Xavier District and RDS DEVCO, LLC;
25		$provided\ that\ the\ Tohono\ O'odham\ Legislative\ Council\ is\ not\ waiving\ the\ Nation's$
26		sovereign immunity or the San Xavier District's right to assert the defense of
27		sovereign immunity except as expressly set forth, referred to, and provided for in
28		this resolution and the Construction Services Agreement.
29	BE IT FINALLY	Y RESOLVED by the Tohono O'odham Legislative Council that the limited waiver of
30		sovereign immunity applies only to claims against the San Xavier District arising
31		out of the Construction Services Agreement, which shall in no way be construed
32		or interpreted as a waiver of the sovereign immunity of the Tohono O'odham
