

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2021 Planning and Economic Development Department Real
Property Management Revenue Budget)**

RESOLUTION NO. 21-075

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Planning and Economic Development Department has prepared and**
8 **submitted for review and approval its FY 2021 Real Property Management**
9 **Revenue Budget, which is incorporated by this reference, in the amount of**
10 **\$348,000.00 to be funded from the Tohono O'odham Nation's Lease Revenue**
11 **Account; and**

12 **WHEREAS, the Commerce and Budget and Finance Committees have reviewed the FY 2021**
13 **Planning and Economic Development Department Real Property Management**
14 **Revenue Budget and recommend its approval.**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
16 **FY 2021 Planning and Economic Development Real Property Management**
17 **Revenue Budget effective October 1, 2020 in the amount of \$348,000.00, which**
18 **shall be funded by the Tohono O'odham Nation's Lease Revenue Account.**

19 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
20 **Nation chairperson or any designated official is authorized to administer and**
21 **expend the FY 2021 Planning and Economic Development Department Real**
22 **Property Management Revenue Budget, provided that any amendments or**
23 **modifications shall be submitted for prior approval by the Tohono O'odham**
24 **Legislative Council.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 01ST**
26 **day of MARCH, 2021 at a meeting at which a quorum was present with a vote of 3,175.7 FOR; -0-**
27 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**
28 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**
29 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
30 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
31 **18, 1934 (48 Stat.984).**
