

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2021 Tohono O'odham Nation Healthcare Desert Diamond
Casinos Gaming Enterprise Funding Budget)

RESOLUTION NO. 21-077

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Tohono O'odham Nation Healthcare ("TONHC") Governing Body was**
8 **delegated the authority to review and approve all TONHC budgets and budgets**
9 **expending health self-governance funds, including budgets expending such**
10 **funds for supporting programs within other Nation's departments, subject to**
11 **Legislative Council oversight committee review and final approval by Legislative**
12 **Council resolution (Tohono O'odham Nation Healthcare Governing Body Bylaws,**
13 **Section 9403 (A)); and**

14 **WHEREAS, the Tohono O'odham Nation Healthcare has prepared and submitted for review**
15 **and approval its FY 2021 Desert Diamond Casinos Gaming Enterprise Funding**
16 **Budget, which is incorporated by this reference, in the amount of \$9,985.00 to be**
17 **funded from Desert Diamond Casino; and**

18 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**
19 **reviewed the FY 2021 Tohono O'odham Nation Healthcare Desert Diamond**
20 **Casinos Gaming Enterprise Funding Budget and recommend its approval.**

21 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
22 **FY 2021 Tohono O'odham Nation Healthcare Desert Diamond Casinos Gaming**
23 **Enterprise Funding Budget effective October 1, 2020 in the amount of \$9,985.00,**
24 **which shall be funded by Desert Diamond Casino.**

25 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
26 **Nation chairperson or any designated official is authorized to administer and**
27 **expend the FY 2021 Tohono O'odham Nation Healthcare Desert Diamond Casinos**
28 **Gaming Enterprise Funding Budget, provided that any amendments or**
29 **modifications shall be submitted for prior approval by the Tohono O'odham**
30 **Legislative Council.**


