

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2021 Sells District COVID-19 CARES Budget)**

RESOLUTION NO. 21-082

1 **WHEREAS,** pursuant Article IX, Section 7 of the Constitution of the Tohono O'odham Nation,
2 **No district council shall expend district funds except pursuant to budgets**
3 **authorized under resolutions of the district council and approved by the**
4 **Tohono O'odham Council. The management of these funds shall be only by**
5 **a treasurer or other authorized officer of the district council who has**
6 **furnished a surety bond satisfactory to the treasurer of the Tohono**
7 **O'odham Nation, and all expenditures of these funds shall be by checks**
8 **signed by such treasurer or other authorized officer and the chairman or**
9 **vice chairman of the district council.**

11 **WHEREAS,** by Resolution No. 20-226, the Legislative Council approved the FY 2021 Tohono
12 **O'odham Nation Coronavirus Relief Fund Budget in the amount of \$61,115,398.00**
13 **effective March 1, 2020 through December 30, 2020 and subsequently amended**
14 **the FY 2021 Tohono O'odham Nation Coronavirus Relief Fund Budget by**
15 **Resolution No. 21-018 to extend the budget time period from March 1, 2020**
16 **through December 31, 2021; and**

17 **WHEREAS,** by Sells District Council Resolution No. SD-22-21, the Sells District has authorized
18 **the FY 2021 Sells District COVID-19 CARES Budget, which is incorporated by this**
19 **reference, in the amount of \$506,230.87 to be funded from Tohono O'odham**
20 **Nation Coronavirus Relief Fund; and**

21 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2021 Sells District COVID-
22 **19 CARES Budget and recommends its approval.**

23 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
24 **FY 2021 Sells District COVID-19 CARES Budget in the amount of \$506,230.87**
25 **effective March 1, 2020 through December 31, 2021, which shall be funded by**
26 **Tohono O'odham Nation Coronavirus Relief Fund.**

27 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the FY 2021 Sells
28 **District COVID-19 CARES Budget shall be managed and expended in accordance**
29 **with Article IX, Section 7 of the Constitution of the Tohono O'odham Nation and**
30 **the Nation's laws, provided that any amendments or modifications shall be**
31 **authorized under District Council resolution and submitted for prior approval by**
32 **the Tohono O'odham Legislative Council.**

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 15TH day of MARCH, 2021 at a meeting at which a quorum was present with a vote of 3,175.7 FOR; -0- AGAINST; [01] NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).
