

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2021 EDD Gaming Negotiating Committee Budget Amendment No. 1)

RESOLUTION NO. 21-083

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2021 EDD Gaming Negotiating Committee Budget in the amount of**
8 **\$2,315,800.00 was approved by Resolution No. 20-282; and**

9 **WHEREAS, the Executive Branch has prepared and submitted for review and approval its FY**
10 **2021 EDD Gaming Negotiating Committee Budget Amendment No. 1, which is**
11 **incorporated by this reference and which will adjust operational and/or**
12 **personnel line items; and**

13 **WHEREAS, the FY 2021 EDD Gaming Negotiating Committee Budget Amendment No. 1 will**
14 **not change the original budget amount of \$2,315,800.00; and**

15 **WHEREAS, the Budget and Finance and Commerce Committees have reviewed the FY 2021**
16 **EDD Gaming Negotiating Committee Budget Amendment No. 1 and recommend**
17 **its approval.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
19 **FY 2021 EDD Gaming Negotiating Committee Budget Amendment No. 1 effective**
20 **October 1, 2020, which does not change the original budget amount of**
21 **\$2,315,800.00.**

22 **BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the Tohono**
23 **O'odham Nation chairperson or any designated official is authorized to**
24 **administer and expend the FY 2021 EDD Gaming Negotiating Committee Budget**
25 **as amended, provided that any amendments or modifications shall be submitted**
26 **for prior approval by the Tohono O'odham Legislative Council.**

27 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
28 **Gaming Enterprise is directed to promptly pay the balance of the amount**
29 **identified in closed session on March 15, 2021.**

30 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 15TH**
31 **day of MARCH, 2021 at a meeting at which a quorum was present with a vote of 3,175.7 FOR; -0-**
32 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
33 **Article VI, Section 1(d)(2)and(3) of the Constitution of the Tohono O'odham Nation, adopted by**
34 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
35 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
36 **18, 1934 (48 Stat.984).**
