

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2021 Department of Health and Human Services Division of Senior**  
**Services Title III CARES Act Budget)**

**RESOLUTION NO. 21-085**

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds  
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate  
3 these funds for the benefit of the nation and its members" provided that "[a]ll  
4 expenditures of these funds shall be pursuant to appropriations or budgets"  
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham  
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the Department of Health and Human Services received a grant award from Inter  
8 Tribal Council of Arizona, Inc. for Title III Coronavirus Aid, Relief, and Economic  
9 Security Act ("CARES Act") grant in the amount of \$40,726.00 for the period of July  
10 1, 2020 to June 30, 2021 for supportive services for coronavirus response efforts;  
11 and

12 **WHEREAS,** the Department of Health and Human Services has prepared and submitted for  
13 review and approval its FY 2021 Division of Senior Services Title III CARES Act  
14 Budget, which is incorporated by this reference, in the amount of \$40,726.00 to be  
15 funded by the Nation's general fund pending reimbursement from Inter Tribal  
16 Council of Arizona, Inc.; and

17 **WHEREAS,** the Health and Human Services and Budget and Finance Committees have  
18 reviewed the FY 2021 Department of Health and Human Services Division of  
19 Senior Services Title III CARES Act Budget and recommend its approval.

20 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
21 FY 2021 Department of Health and Human Services Division of Senior Services  
22 Title III CARES Act Budget, effective July 1, 2020 to June 30, 2021, in the amount of  
23 \$40,726.00, which shall be funded by the Nation's general fund pending  
24 reimbursement from Inter Tribal Council of Arizona, Inc.

25 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham  
26 Nation chairperson or any designated official is authorized to administer and  
27 expend the FY 2021 Department of Health and Human Services Division of Senior  
28 Services Title III CARES Act Budget, provided that any amendments or  
29 modifications shall be submitted for prior approval by the Tohono O'odham  
30 Legislative Council.
