The management of these funds shall be only by 5 a treasurer or other authorized officer of the district council who has 6 furnished a surety bond satisfactory to the treasurer of the Tohono 7 O'odham Nation, and all expenditures of these funds shall be by checks 8 9 signed by such treasurer or other authorized officer and the chairman or vice chairman of the district council. 10 11 ; and the FY 2021 Pisinemo District Coronavirus Assistance Relief Fund Assistance 12 WHEREAS, Program Budget in the amount of \$470,481.28 was approved by Resolution No. 20-13 389 to be funded by the FY 2021 Tohono O'odham Nation Coronavirus Relief Fund 14 Budget for the period of March 1, 2020 to December 30, 2020; and 15 Congress extended the federal deadline for expending the Coronavirus Relief 16 WHEREAS, Fund and by Resolution No. 21-018, the Legislative Council extended the time 17 period for expending the FY 2021 Tohono O'odham Nation Coronavirus Relief 18 Fund Budget to December 31, 2021; and 19 by Pisinemo District Council Resolution No. 21-P-25, the Pisinemo District has 20 WHEREAS. authorized and submitted for review and approval its FY 2021 Pisinemo District 21 Coronavirus Assistance Relief Fund Assistance Program Budget Amendment No. 22 1. which is incorporated by this reference; and 23 the FY 2021 Pisinemo District Coronavirus Assistance Relief Fund Assistance 24 WHEREAS.
