16		applicant, and the Enrollment Committee's recommendation that the					
17		application be approved or rejected;					
18		(2) If an application for membership is approved, the applicant's date of					
19		birth, the membership requirement which Council determined that the					
20		applicant established, and the Enrollment Committee's recommendation					
21		that the application be approved or rejected.
