

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending Enrollment Resolution Nos. 114-80, 03-301, 04-659, 05-711 and 19-069
to Correct Names of Enrolled Members)**

RESOLUTION NO. 21-090

1 **WHEREAS,** the Tohono O'odham Legislative Council is vested with the power to enact laws
2 and ordinances governing the enrollment and adoption of members
3 (Constitution of the Tohono O'odham Nation, Article II, Sections 1 and 2 and
4 Article VI, Section 1(h)); and

5 **WHEREAS,** pursuant to Article VI and VII of the Nation's Enrollment Ordinance, the
6 Enrollment Committee shall review membership applications and make a
7 written recommendation to the Tohono O'odham Legislative Council to approve
8 or reject the application (14 Tohono O'odham Code Chapter 1 - Enrollment
9 Ordinance); and

10 **WHEREAS,** pursuant to Article VIII of the Nation's Enrollment Ordinance, the Tohono
11 O'odham Legislative Council shall determine eligibility for membership or
12 adoption; and

13 **WHEREAS,** the Enrollment Program has determined that a number of resolutions approving
14 membership and adoption applications misspelled or incorrectly listed the
15 names of members; and

16 **WHEREAS,** the Enrollment Program recommends that Resolution Nos. 114-80, 03-301, 04-
17 659, 05-711 and 19-069 be amended to reflect the correct names for the members
18 identified in the April 2021 Corrected Enrollment Resolution Summary, which is
19 incorporated by this reference.

20 **NOW, THEREFORE, BE IT RESOLVED** by the Tohono O'odham Legislative Council that Resolution
21 Nos. 114-80, 03-301, 04-659, 05-711 and 19-069 are amended upon the effective
22 date of those resolutions to reflect the correct names of members identified in
23 the April 2021 Corrected Enrollment Resolution Summary.

24 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05TH
25 day of APRIL, 2021 at a meeting at which a quorum was present with a vote of 3,175.7 FOR; -0-
26 AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by
27 Article II, Sections 1 and 2 and Article VI, Section 1(h) of the Constitution of the Tohono O'odham
28 Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting
29 Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section
30 16 of the Act of June 18, 1934 (48 Stat.984).
