

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2021 Department of Membership Services Enrollment Payment Roll
Budget Amendment No. 1)

RESOLUTION NO. 21-093

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the FY 2021 Department of Membership Services Enrollment Payment Roll
8 Budget in the amount of \$395,104.80 was approved by Resolution No. 20-253; and

9 **WHEREAS,** the Department of Membership Services has prepared and submitted for review
10 and approval its FY 2021 Enrollment Payment Roll Budget Amendment No. 1,
11 which is incorporated by this reference and which will adjust operational and/or
12 personnel line items; and

13 **WHEREAS,** the FY 2021 Department of Membership Services Enrollment Payment Roll
14 Budget Amendment No. 1 will not change the budget amount of \$395,104.80; and

15 **WHEREAS,** the Rules and Budget and Finance Committees have reviewed the FY 2021
16 Department of Membership Services Enrollment Payment Roll Budget
17 Amendment No. 1 and recommend its approval.

18 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
19 FY 2021 Department of Membership Services Enrollment Payment Roll Budget
20 Amendment No. 1, which does not change the budget amount of \$395,104.80.

21 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
22 Nation chairperson or any designated official is authorized to administer and
23 expend the FY 2021 Department of Membership Services Enrollment Payment
24 Roll Budget as amended, provided that any amendments or modifications shall
25 be submitted for prior approval by the Tohono O'odham Legislative Council.

26 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05TH
27 day of APRIL, 2021 at a meeting at which a quorum was present with a vote of 2,961.9 FOR; 213.8
28 AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by
29 Article VI, Section 1(d)(2)and(3) of the Constitution of the Tohono O'odham Nation, adopted by
30 the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
31 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
32 18, 1934 (48 Stat.984).
