

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2021 Department of Membership Services Enrollment Program
Budget Amendment No. 1)**

RESOLUTION NO. 21-094

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2021 Department of Membership Services Enrollment Program Budget in**
8 **the amount of \$415,515.81 was approved by Resolution No. 20-282; and**

9 **WHEREAS, the Department of Membership Services has prepared and submitted for review**
10 **and approval its FY 2021 Enrollment Program Budget Amendment No. 1, which is**
11 **incorporated by this reference and which will adjust operational and/or**
12 **personnel line items; and**

13 **WHEREAS, the FY 2021 Department of Membership Services Enrollment Program Budget**
14 **Amendment No. 1 will not change the budget amount of \$415,515.81; and**

15 **WHEREAS, the Rules and Budget and Finance Committees have reviewed the FY 2021**
16 **Department of Membership Services Enrollment Program Budget Amendment**
17 **No. 1 and recommend its approval.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
19 **FY 2021 Department of Membership Services Enrollment Program Budget**
20 **Amendment No. 1, which does not change the budget amount of \$415,515.81.**

21 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
22 **Nation chairperson or any designated official is authorized to administer and**
23 **expend the FY 2021 Department of Membership Services Enrollment Program**
24 **Budget as amended, provided that any amendments or modifications shall be**
25 **submitted for prior approval by the Tohono O'odham Legislative Council.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05TH**
27 **day of APRIL, 2021 at a meeting at which a quorum was present with a vote of 2,961.9 FOR; -0-**
28 **AGAINST; -0- NOT VOTING; and 213.8[04] ABSENT, pursuant to the powers vested in the Council**
29 **by Article VI, Section 1(d)(2)and(3) of the Constitution of the Tohono O'odham Nation, adopted**
30 **by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**
31 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the**
32 **Act of June 18, 1934 (48 Stat.984).**
