

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2021 Department of Education Higher Education Services Budget
Amendment No. 1)**

RESOLUTION NO. 21-096

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the FY 2021 Department of Education Higher Education Services Budget in the
8 amount of \$922,576.14 was approved by Resolution No. 20-249; and

9 **WHEREAS,** the Department of Education has prepared and submitted for review and
10 approval its FY 2021 Higher Education Services Budget Amendment No. 1, which
11 is incorporated by this reference and which will adjust operational and/or
12 personnel line items; and

13 **WHEREAS,** the FY 2021 Department of Education Higher Education Services Budget
14 Amendment No. 1 will not change the total budget amount of \$922,576.14; and

15 **WHEREAS,** the Human Resources Development and Budget and Finance Committees have
16 reviewed the FY 2021 Department of Education Higher Education Services Budget
17 Amendment No. 1 and recommend its approval.

18 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
19 FY 2021 Department of Education Higher Education Services Budget Amendment
20 No. 1 effective October 1, 2020, which will not change the total budget amount of
21 \$922,576.14.

22 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
23 Nation chairperson or any designated official is authorized to administer and
24 expend the FY 2021 Department of Education Higher Education Services Budget
25 as amended, provided that any amendments or modifications shall be submitted
26 for prior approval by the Tohono O'odham Legislative Council.

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05TH**
28 **day of APRIL, 2021 at a meeting at which a quorum was present with a vote of 3,175.7 FOR; -0-**
29 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
30 **Article VI, Section 1(d)(2)and(3) of the Constitution of the Tohono O'odham Nation, adopted by**
31 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
32 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
33 **18, 1934 (48 Stat.984).**
