

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending FY 2021 Tohono O'odham Nation Coronavirus Relief Fund
Budget Amendment No. 2)

RESOLUTION NO. 21-108

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the FY 2021 Tohono O'odham Nation Coronavirus Relief Fund Budget in the
8 amount of \$61,115,398.00 was approved by Resolution No. 20-226 and
9 subsequently amended by Resolution No. 21-018; and

10 **WHEREAS,** the Executive Branch has prepared and submitted for review and approval its FY
11 2021 Tohono O'odham Nation Coronavirus Relief Fund Budget Amendment No. 2,
12 which is incorporated by this reference and which will adjust operational and/or
13 personnel line items; and

14 **WHEREAS,** the FY 2021 Tohono O'odham Nation Coronavirus Relief Fund Budget
15 Amendment No. 2 will not change the original budget amount of \$61,115,398.00;
16 and

17 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2021 Tohono O'odham
18 Nation Coronavirus Relief Fund Budget Amendment No. 2 and recommends
19 approval.

20 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
21 FY 2021 Tohono O'odham Nation Coronavirus Relief Fund Budget Amendment
22 No. 2, effective March 1, 2020 through December 31, 2021, which shall not change
23 the original budget amount of \$61,115,398.00.

24 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
25 Nation chairperson or any designated official is authorized to administer and
26 expend the FY 2021 Tohono O'odham Nation Coronavirus Relief Fund Budget as
27 amended, provided that any amendments or modifications shall be submitted
28 for prior approval by the Tohono O'odham Legislative Council.

29 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06TH**
30 **day of APRIL, 2021 at a meeting at which a quorum was present with a vote of 3,175.7 FOR; -0-**
31 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**
32 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**
33 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
34 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
35 **18, 1934 (48 Stat.984).**
