

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2021 Baboquivari District Topawa Community Budget Amendment No. 1, FY 2021 Choulic Community Budget Amendment No. 3, and FY 2021 Cold Fields Community Budget Amendment No. 2)

RESOLUTION NO. 21-111

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham
2 Nation,

3 **No district council shall expend district funds except pursuant to budgets**
4 **authorized under resolutions of the district council and approved by the**
5 **Tohono O'odham Council. The management of these funds shall be only by**
6 **a treasurer or other authorized officer of the district council who has**
7 **furnished a surety bond satisfactory to the treasurer of the Tohono**
8 **O'odham Nation, and all expenditures of these funds shall be by checks**
9 **signed by such treasurer or other authorized officer and the chairman or**
10 **vice chairman of the district council.**

11 ; and

12 **WHEREAS,** the FY 2021 Baboquivari District Budgets in the amount of \$3,074,043.86 was
13 authorized by Baboquivari District Council Resolution No. 2020-B-75 and
14 approved by Legislative Council Resolution No. 20-315, and subsequently
15 amended by Resolution No. 21-025 in the amount of \$3,942,345.77 and by
16 Resolution No. 21-081 in the amount of \$4,107,828.14; and

17 **WHEREAS,** by Baboquivari District Council Resolution Nos. 2021-B-22, 2021-B-23, and 2021-
18 B-27 the Baboquivari District has authorized and submitted for review and
19 approval its FY 2021 Baboquivari District Topawa Community Budget
20 Amendment No. 1, FY 2021 Baboquivari District Choulic Community Budget
21 Amendment No. 3, and FY 2021 Baboquivari District Cold Fields Community
22 Budget Amendment No. 2, which are incorporated by this reference and which
23 will adjust operational and/or personnel line items; and

24 **WHEREAS,** the FY 2021 Baboquivari District Topawa Community Budget Amendment No. 1
25 will increase the FY 2021 Topawa Community Budget by \$222,820.33 from
26 \$355,930.12 to \$578,750.45 that shall be funded by FY 2014, FY 2015, and partial FY
27 2016 carry forward funds; and

28 **WHEREAS,** the FY 2021 Baboquivari District Choulic Community Budget Amendment No. 3
29 will not change the original FY 2021 Choulic Community Budget amount of
30 \$701,429.99; and

1 **WHEREAS, the FY 2021 Baboquivari District Cold Fields Community Budget Amendment No.**
2 **2 will not change the original FY 2021 Cold Fields Community Budget amount of**
3 **\$355,930.12; and**

4 **WHEREAS, the Budget and Finance Committee has reviewed the FY 2021 Baboquivari District**
5 **Topawa Community Budget Amendment No. 1, FY 2021 Baboquivari District**
6 **Choulic Community Budget Amendment No. 3, and FY 2021 Baboquivari District**
7 **Cold Fields Community Budget Amendment No. 2 and recommend their**
8 **approval.**

9 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves FY**
10 **2021 Baboquivari District Topawa Community Budget Amendment No. 1 effective**
11 **October 1, 2020, which includes a \$222,820.33 increase from \$355,930.12 to**
12 **\$578,750.45 that shall be funded by carry forward funds as follows:**

- 13 **(1) FY 2014 carry forward funds in the amount of \$96,913.81;**
- 14 **(2) FY 2015 carry forward funds in the amount of \$93,386.99; and**
- 15 **(3) FY 2016 carry forward funds a portion in the amount of \$32,519.53.**

16 **BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council approves the FY 2021**
17 **Baboquivari District Choulic Community Budget Amendment No. 3 and the FY**
18 **2021 Baboquivari District Cold Fields Community Budget Amendment No. 2,**
19 **which will not change the original budget amounts.**

20 **BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the FY 2021**
21 **Baboquivari Districts Budget is increased by \$222,820.33 from \$4,107,828.14 to**
22 **\$4,330,648.47.**

23 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the FY 2021**
24 **Baboquivari District Topawa Community Budget, FY 2021 Baboquivari District**
25 **Choulic Community Budget, and the FY 2021 Baboquivari District Cold Fields**
26 **Community Budget as amended shall be managed and expended in accordance**
27 **with Article IX, Section 7 of the Constitution of the Tohono O'odham Nation and**
28 **the Nation's laws, provided that any amendments or modifications shall be**
29 **authorized under District Council resolution and submitted for prior approval by**
30 **the Tohono O'odham Legislative Council.**

31 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH**
32 **day of APRIL, 2021 at a meeting at which a quorum was present with a vote of 3,175.7 FOR; -0-**
33 **AGAINST; [01] NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
34 **Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
35 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
36 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934**
37 **(48 Stat.984).**
