**RESOLUTION NO. 21-112** 

1	WHEREAS	the Constitution of the Tohono O'odham Nation vests the Legislative Council with
2		the authority to "authorize, charter and regulate public or private corporations
3		and associations" and to "provide for, appoint, or provide for the appointment of,
4		and prescribe the duties and powers of committees, boards, officers and agents
5		(Constitution, Article VI, Section 1(e) and 1(b)); and
6	WHEREAS	by Resolution No. 93-311, the Legislative Council approved the charter of the
7		Tohono O'odham Gaming Authority, subsequently renamed as the Tohono
8		O'odham Gaming Enterprise (the "Gaming Enterprise"), as a wholly owned tribal
9		government enterprise that is responsible for operating the Nation's gaming
0	9	facilities and conducting gaming activities (Charter of the Gaming Enterprise
1		("Charter"), as amended, 16 Tohono O'odham Code Chapter 2); and
12	WHEREAS	
13		Management Board that is vested with authority to "[e]xercise general authority
14		and responsibility for the management and operation of the Enterprise" and
15		perform additional functions (Charter, Section 5(a)(1) and 5(c)(3)); and
16	WHEREAS	, the Management Board may adopt bylaws or rules governing its meetings
17		pursuant to Section 5(d)(17) of the Charter; and
18	WHEREAS	
19		meeting of four Directors shall constitute a quorum of the Management Board for
20		transaction of any business," with only four current Directors, the Management
21		Board will not achieve a quorum if any director is unavailable to meet; and
22	WHEREAS	
23		in the Management Board's quorum requirement to three Directors through
24		April 14, 2021, in order to ensure that the Management Board is able to transact
25		business; and

27		the Management Board's quorum requirement through August 31, 2021 to
28		provide the Committee sufficient time to present to the Legislative Council
29		Charter amendments or other actions necessary to ensure that the Management
30		Board may transact business.
31	NOW, TH	IEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that,
32		notwithstanding Section 5(c)(3) of the Gaming Enterprise Charter, the presence at
33		any meeting of three Directors shall constitute a quorum of the Management
34		Board for transaction of any business; provided that (1) the provisions of this
35		resolution shall automatically expire on August 31, 2021 and (2) the Commerce
