

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Amending Resolution No. 20-339, "Approving FY 2020 Department of Education One**  
**Stop Division PY19/FY20 Budgets Amendment No. 1" to Correct Dates)**

**RESOLUTION NO. 21-135**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**  
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**  
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**  
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**  
6 **Nation, Article VI Section 1(d)(2)); and**

7 **WHEREAS, by Resolution No. 20-197, the Legislative Council approved Intergovernmental**  
8 **Agreement Amendment No. 1 with the Arizona Department of Economic Security**  
9 **to increase funding to the Tohono O'odham Nation One Stop Division in the**  
10 **amount of \$620,269.00 for the time period beginning on July 1, 2019 through June**  
11 **30, 2021; and**

12 **WHEREAS, by Resolution No. 20-339, the Legislative Council approved the FY 2020**  
13 **Department of Education One Stop Division PY19/FY20 Budgets Amendment No.**  
14 **1, in the amount of \$620,269.00 effective July 1, 2019 through June 30, 2020; and**


15 **WHEREAS, it is necessary to amend Resolution No. 20-339 to correct the budget period dates**  
16 **from July 1, 2019 through June 30, 2021; and**

17 **WHEREAS, the Human Resources Development Committee has reviewed the amendment to**  
18 **Resolution No. 20-339 and recommends approval.**

19 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council**  
20 **amends Resolution No. 20-339 to correct the budget period dates for the FY 2020**  
21 **Department of Education One Stop Division PY19/FY20 Budgets from July 1, 2019**  
22 **through June 30, 2021.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 03<sup>RD</sup>**  
24 **day of MAY, 2021 at a meeting at which a quorum was present with a vote of 1,677.6 FOR; 1,498.1**  
25 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**  
26 **Article VI, Section 1(d)(2)and(3) of the Constitution of the Tohono O'odham Nation, adopted by**  
27 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
28 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
29 **18, 1934 (48 Stat.984).**
