

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2021 Department of Health and Human Services Division of Family
Assistance BIA Social Services Program Budget Amendment No. 1)**

RESOLUTION NO. 21-136

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the FY 2021 Department of Health and Human Services Division of Family
8 Assistance BIA Social Services Program Budget in the amount of \$1,417,822.00
9 was approved by Resolution No. 20-249; and

10 **WHEREAS,** the Department of Health and Human Services has prepared and submitted for
11 review and approval its FY 2021 Division of Family Assistance BIA Social Services
12 Program Budget Amendment No. 1, which is incorporated by this reference and
13 which will adjust operational and/or personnel line items and decrease indirect
14 costs; and

15 **WHEREAS,** the FY 2021 Department of Health and Human Services BIA Social Services
16 Program Budget Amendment No. 1 will increase the FY 2021 Division of Family
17 Assistance BIA Social Services Program Budget by \$130,460.25 from \$1,417,822.00
18 to \$1,548,282.25; and

19 **WHEREAS,** the Health and Human Services and Budget and Finance Committees have
20 reviewed the FY 2021 Department of Health and Human Services Division of
21 Family Assistance BIA Social Services Program Budget Amendment No. 1 and
22 recommend its approval.

23 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
24 FY 2021 Department of Health and Human Services Division of Family Assistance
25 BIA Social Services Program Budget Amendment No. 1 effective October 1, 2020,
26 which includes a \$130,460.25 increase from \$1,417,822.00 to \$1,548,282.25 that
27 shall be funded by the Bureau of Indian Affairs Funding Agreement.

28 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
29 Nation chairperson or any designated official is authorized to administer and
30 expend the FY 2021 Department of Health and Human Services Division of Family
31 Assistance BIA Social Services Program Budget as amended, provided that any
32 amendments or modifications shall be submitted for prior approval by the
33 Tohono O'odham Legislative Council.
