

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2021 Department of Health and Human Services Division of Senior
Services Title VI CARES Act Budget Amendment No. 1)

RESOLUTION NO. 21-139

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the FY 2021 Department of Health and Human Services ("DHHS") Division of
8 Senior Services Title VI CARES Act Budget in the amount of \$116,750.00 was
9 approved by Resolution No. 20-217; and

10 **WHEREAS,** the DHHS has prepared and submitted for review and approval its FY 2021
11 Division of Senior Services Title VI CARES Act Budget Amendment No. 1, which is
12 incorporated by this reference and which will adjust operational and/or
13 personnel line items and decrease indirect cost; and

14 **WHEREAS,** the FY 2021 Department of Health and Human Services Division of Senior Services
15 Title VI CARES Act Budget Amendment No. 1 will not change the budget amount of
16 \$116,750.00; and

17 **WHEREAS,** the Health and Human Services and Budget and Finance Committees have
18 reviewed the FY 2021 DHHS Division of Senior Services Title VI CARES Act Budget
19 Amendment No. 1 and recommend its approval.

20 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
21 FY 2021 Department of Health and Human Services Division of Senior Services
22 Title VI CARES Act Budget Amendment No. 1 effective April 1, 2020 through
23 September 30, 2021 and which does not change the budget amount of \$116,750.00.

24 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
25 Nation chairperson or any designated official is authorized to administer and
26 expend the FY 2021 Department of Health and Human Services Division of Senior
27 Services Title VI CARES Act Budget as amended, provided that any amendments
28 or modifications shall be submitted for prior approval by the Tohono O'odham
29 Legislative Council.

30 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 04TH**
31 **day of MAY, 2021 at a meeting at which a quorum was present with a vote of 3,175.7 FOR; -0-**
32 **AGAINST; -0- NOT VOTING; and -0- ABSENT, pursuant to the powers vested in the Council by**
33 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**
34 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
35 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
36 **18, 1934 (48 Stat.984).**




