

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2021 Department of Health and Human Services Division of
Senior Services Title III Budgets Amendments No. 1)

RESOLUTION NO. 21-140

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2021 Department of Health and Human Services ("DHHS") Division of**
8 **Senior Services B-1 Transportation Budget; C-1 Congregate Budget; C-2 Home**
9 **Delivered Meals Budget; E-Caregiver Outreach Budget; LTC Ombudsman Budget**
10 **(collectively the "Title III Budgets") in the amount of \$75,473.00 were approved by**
11 **Resolution No. 20-203; and**

12 **WHEREAS, the DHHS has prepared and submitted for review and approval its FY 2021**
13 **Division of Senior Services Title III Budgets Amendments No. 1: B-1**
14 **Transportation; C-1 Congregate; and C-2 Home Delivered Meals, which are**
15 **incorporated by this reference and which will adjust operational and/or**
16 **personnel line items; and**

17 **WHEREAS, the DHHS Division of Senior Services Tribal Budget 001-21-6201 is the**
18 **contributing source to meet the match for in-kind services for Title III Budgets;**
19 **and**

20 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**
21 **reviewed the FY 2021 DHHS Division of Senior Services Title III Budgets**
22 **Amendments No. 1 and recommend their approval.**

23 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
24 **FY 2021 Department of Health and Human Services Division of Senior Services**
25 **Title III Budgets Amendments No. 1 effective July 1, 2020 through June 30, 2021,**
26 **and waives indirect costs, as follows:**

- 27 1. **B-1 Transportation Budget decrease of \$247.00 from \$16,247.00 to**
28 **\$16,000.00;**
- 29 2. **C-1 Congregate Budget increase of \$19,033.00 from \$29,250.00 to**
30 **\$48,283.00; and**
- 31 3. **C-2 Home Delivered Meals Budget increase of \$23,524.00 from \$19,476.00**



3 expend the FY 2021 Department of Health and Human Services Division of Senior
4 Services Title III Budgets: B-1 Transportation; C-1 Congregate; C-2 Home
5 Delivered Meals as amended, provided that any amendments or modifications
6 shall be submitted for prior approval by the Tohono O'odham Legislative Council.


7 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 04TH
8 day of MAY, 2021 at a meeting at which a quorum was present with a vote of 3,175.7 FOR; -0-
9 AGAINST; -0- NOT VOTING; and -0- ABSENT, pursuant to the powers vested in the Council by
10 Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by
11 the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
12 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
13 18, 1934 (48 Stat.984).


