

**RESOLUTION OF THE TOHONO O’ODHAM LEGISLATIVE COUNCIL
(Appointing Beth Michel to the Nation’s Institutional Review Board)**

RESOLUTION NO. 21-143

1 **WHEREAS,** the Constitution of the Tohono O’odham Nation vests the Legislative Council with
2 the authority to “promote, protect and provide for public health, peace, morals,
3 education and general welfare of the Tohono O’odham Nation and its members...”
4 and to “provide for, appoint, or provide for the appointment of, and prescribe the
5 duties and powers of committees, boards, officers and agents...” (Constitution,
6 Article VI, Section 1(c)(2) and Section 1(b)); and

7 **WHEREAS,** the Nation’s Research Code, enacted May 23, 2013, establishes a permit
8 requirement for any researcher seeking to conduct research on the Nation, a
9 Nation’s Institutional Review Board to review and consider research proposals,
10 and a requirement that researchers enter into a research agreement with the
11 Nation (17 Tohono O’odham Code Chapter 8); and

12 **WHEREAS,** the Nation’s Institutional Review Board is comprised of five enrolled Nation’s
13 members with sufficient education and experience in different academic fields
14 or in the Nation’s culture and traditions (17 Tohono O’odham Code Chapter 8,
15 Section 8104); and

16 **WHEREAS,** Institutional Review Board members are nominated by the Nation’s chairperson
17 and appointed by the Legislative Council for staggered three-year terms expiring
18 on September 30 of the third year, provided that members shall serve until
19 replaced (17 Tohono O’odham Code Chapter 8, Section 8104); and

20 **WHEREAS,** Chairman Ned Norris, Jr. has nominated Beth Michel, a Nation’s member with
21 sufficient education and experience in health care for the Institutional Review
22 Board; and


23 **WHEREAS,** the Human Resources Development and Rules Committees have reviewed Beth
24 Michel’s resume, cover letter, and background investigation report and
25 recommend approval.

26 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O’odham Legislative Council appoints Beth
27 Michel, a Nation’s member with sufficient education and experience in health
28 care under Section 8104 (C)(2) of the Nation’s Research Code, to the Institutional
29 Review Board for a three-year term beginning on the effective date of this
30 resolution and expiring September 30, 2024, provided that she shall continue to
31 serve until replaced.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 04TH day of MAY, 2021 at a meeting at which a quorum was present with a vote of 3,175.7 FOR; -0- AGAINST; [01] NOT VOTING; and -0- ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(c)(2) and Section 1(b) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).
