**RESOLUTION NO. 21-144** 

1	WHEREAS,	the Constitution of the Tohono O'odham Nation vests the Legislative Council with					
2		the power to "provide for, appoint, or provide for the appointment of, and					
3		prescribe the duties and powers of committees, boards, officers and agents"					
4		(Constitution, Article VI, Section 1(b)); and					
5	WHEREAS,	by Resolution No. 91-175, the Legislative Council adopted the Second Restated					
6		Plan of Operation of the Tohono O'odham Utility Authority ("TOUA Plan of					
7		Operation") (24 Tohono O'odham Code Chapter 1); and					
8	WHEREAS,	the TOUA Plan of Operation provides for a Management Board consisting of seven					
9		members that are appointed by the chairperson of the Nation, subject to approval					
10		by the Legislative Council, to serve three year terms (Section 9(A) of the TOUA Plan					
11		of Operation); and					
12	WHEREAS,	Chairman Ned Norris, Jr. has appointed Theresa Bourne to the TOUA					
13		Management Board, subject to Legislative Council approval; and					
14	WHEREAS,	Theresa Bourne has 26 years of experience working for the City of Tucson Water					
15		Department in several divisions, including the Planning and Engineering					
16		Division, Business Services Division, and as a Management Coordinator; and					
17	WHEREAS,	the Commerce and Rules Committees have reviewed Theresa Bourne's					
18		appointment and recommend approval.					
19	NOW, THEREFORE, BE IT RESOLVED that notwithstanding Section 9(C)(2) of the TOUA Plan of						
20		Operation, the Tohono O'odham Legislative Council approves the appointment of					
21		Theresa Bourne to the Management Board of the Tohono O'odham Utility					
22		Authority for a term beginning on the effective date of this resolution and					
23		expiring May 14, 2024, provided that Theresa Bourne shall continue to serve until					
24		her successor has been appointed and qualified.
