## RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL (Appointing Judge Kyle Fields to the Tohono O'odham Judicial Court for Another Term)

**RESOLUTION NO. 21-150** 

1	WHEREAS,	the Tohono O'odham Legislative Council is vested with the power to appoint
2		judges to the Tohono O'odham Judicial Court pursuant to the Constitution of the
3		Tohono O'odham Nation, which states, "[t]he Tohono O'odham Courts shall be
4		courts of record and shall consist of at least six (6) judges appointed by the Tohono
5		O'odham Council." (Constitution, Article VIII, Section 3); and
6	WHEREAS,	the Constitution requires the judges' terms to be staggered so that approximately
7		one-third of the judges are appointed every other year (Constitution, Article VIII,
8		Section 4); and
9	WHEREAS,	6 Tohono O'odham Code Chapter 1 - Courts and Procedures, provides in part that
10		trial court judges "serve six-year terms" and "shall continue to discharge the
11		duties of that office, although the judge's term has expired, until a successor is
12		appointed and sworn in." (Section 1103(A) and (B)); and
13	WHEREAS,	Judge Kyle Fields' term expired on January 31, 2021 and he continues in office
14		until his successor is appointed and sworn in; and
15	WHEREAS,	Judge Kyle Fields possesses a juris doctorate, is licensed to practice law in
16		Arizona, and is a member in good standing with the State Bar of Arizona; and
17	WHEREAS,	$the \ Judiciary \ Committee, having \ legislative \ oversight \ of \ matters \ pertaining \ to \ the$
18		Tohono O'odham Judicial Court, has reviewed Judge Fields' application and
19		background information, and has interviewed Judge Fields; and
20	WHEREAS,	there are currently three vacancies on the Tohono O'odham Judicial Court with
21		$two \ terms \ expiring \ January \ 31, 2027 \ and \ the \ other \ term \ expiring \ January \ 31, 2025;$
22		and
23	WHEREAS,	the Legislative Council has likewise interviewed Judge Fields and reviewed his
24		application materials and background investigation report.
25	NOW, THERE	FORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it appoints
26		Judge Kyle Fields as a Tohono O'odham Judicial Court judge for another term
27		beginning on the effective date of this resolution and ending January 31, 2027,
28		provided that he shall continue to discharge the duties of the office until a
29		successor is appointed and sworn in if he satisfies the requirements of 6 Tohono
30		O'odham Code Chapter 1, Section 1103 (C)(2) and (3).
