

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2021 Pisinemo District Operations Budget Amendment No. 1)**

**RESOLUTION NO. 21-153**

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham  
2 Nation,

3 No district council shall expend district funds except pursuant to budgets  
4 authorized under resolutions of the district council and approved by the  
5 Tohono O'odham Council. The management of these funds shall be only by  
6 a treasurer or other authorized officer of the district council who has  
7 furnished a surety bond satisfactory to the treasurer of the Tohono  
8 O'odham Nation, and all expenditures of these funds shall be by checks  
9 signed by such treasurer or other authorized officer and the chairman or  
10 vice chairman of the district council.

12 **WHEREAS,** the FY 2021 Pisinemo District Operations Budget in the amount of \$3,074,043.86  
13 was authorized by Pisinemo District Council Resolution No. 20-P-29 and  
14 approved by Legislative Council Resolution No. 20-320; and

15 **WHEREAS,** by Pisinemo District Council Resolution No. 21-P-01, the Pisinemo District has  
16 prepared and submitted for review and approval its FY 2021 Pisinemo District  
17 Operations Budget Amendment No. 1, which is incorporated by this reference and  
18 which will adjust operational and/or personnel line items; and

19 **WHEREAS,** the FY 2021 Pisinemo District Operations Budget Amendment No. 1 will not  
20 change the FY 2021 Pisinemo District Operations Budget amount of  
21 \$3,074,043.86; and

22 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2021 Pisinemo District  
23 Operations Budget Amendment No.1 and recommends its approval.


24 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
25 FY 2021 Pisinemo District Operations Budget Amendment No. 1, which will not  
26 change the FY 2021 Pisinemo District Operations Budget amount of  
27 \$3,074,043.86.

28 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the FY 2021 Pisinemo  
29 District Operations Budget, as amended shall be managed and expended in  
30 accordance with Article IX, Section 7 of the Constitution of the Tohono O'odham  
31 Nation and the Nation's laws, provided that any amendments or modifications  
32 shall be authorized under District Council resolution and submitted for prior  
33 approval by the Tohono O'odham Legislative Council.

1 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07<sup>TH</sup>  
2 day of MAY, 2021 at a meeting at which a quorum was present with a vote of 3,175.7 FOR; -0-  
3 AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by  
4 Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono  
5 O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -  
6 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934  
7 (48 Stat.984).
