

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the FY 2021 Executive Branch Traditional O'odham Leaders/O'odham
in Mexico Budget)**

RESOLUTION NO. 21-154

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section I (d)(2)); and

7 **WHEREAS,** the Tohono O'odham Legislative Council enacted Resolution No. 95-562
8 "Recognition of the O'odham in Mexico Communities and Traditional
9 Government" to address issues for the Tohono O'odham members who reside on
10 Tohono O'odham ancestral land in Mexico; and

11 **WHEREAS,** subsequent to Tohono O'odham Legislative Council Resolution No. 95-562, the
12 Tohono O'odham Legislative Council passed Resolution Nos. 05-725, 13-444, 16-
13 160, 18-049, and 19-417, which updated and/or approved communities and
14 Tohono O'odham leadership and continues to recognize the Traditional
15 O'odham Leaders and their traditional form of government; and

16 **WHEREAS,** the Traditional O'odham Leaders of the 17 communities of Sonora, Mexico,
17 respectfully submitted for consideration, a budget to complete the O'odham in
18 Mexico census, the O'odham Kuinta; and

19 **WHEREAS,** the Executive Branch has prepared and submitted for review and approval its FY
20 2021 Traditional O'odham Leaders/O'odham in Mexico Budget, which is
21 incorporated by this reference, in the amount of \$50,000.00 to be funded by the
22 Nation's general fund surplus; and

23 **WHEREAS,** the Domestic Affairs and Budget and Finance Committees have reviewed the FY
24 2021 Executive Branch Traditional O'odham Leaders/O'odham in Mexico Budget
25 and recommend its approval.

26 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
27 FY 2021 Executive Branch Traditional O'odham Leaders/O'odham in Mexico
28 Budget effective October 1, 2020 in the amount of \$50,000.00, which shall be
29 funded by the Nation's general fund surplus, provided that the funds shall be
30 used exclusively for one or more of the purposes listed under Section 302 of the 16
31 Tohono O'odham Code Chapter 1.

33 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
34 Nation chairperson or any designated official is authorized to administer and



1 expend the FY 2021 Executive Branch Traditional O'odham Leaders/O'odham in
2 Mexico Budget, provided that any amendments or modifications shall be
3 submitted for prior approved by the Tohono O'odham Legislative Council

4 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH
5 day of MAY, 2021 at a meeting at which a quorum was present with a vote of 3,175.7 FOR; -0-
6 AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by
7 Article VI, Section 1(d)(2)and(3) of the Constitution of the Tohono O'odham Nation, adopted by
8 the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
9 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
10 18, 1934 (48 Stat.984).




