

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2021 Planning and Economic Development Department Administration
Budget Amendment No. 1)**

RESOLUTION NO. 21-156

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2021 Planning and Economic Development Department Administration**
8 **Budget in the amount of \$1,146,659.02 was approved by Resolution No. 20-282;**
9 **and**

10 **WHEREAS, the Planning and Economic Development Department has prepared and**
11 **submitted for review and approval its FY 2021 Administration Budget**
12 **Amendment No. 1, which is incorporated by this reference and which will adjust**
13 **operational and/or personnel line items; and**

14 **WHEREAS, the FY 2021 Planning and Economic Development Department Administration**
15 **Budget Amendment No. 1 will decrease the FY 2021 Administration Budget by**
16 **\$8,984.59 from \$1,146,659.02 to \$1,137,674.43; and**

17 **WHEREAS, the Commerce and Budget and Finance Committees have reviewed the FY 2021**
18 **Planning and Economic Development Department Administration Budget**
19 **Amendment No. 1 and recommend its approval.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
21 **FY 2021 Planning and Economic Development Department Administration**
22 **Budget Amendment No. 1, effective October 1, 2020, which includes a \$8,984.59**
23 **decrease from \$1,146,659.02 to \$1,137,674.43.**

24 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
25 **Nation chairperson or any designated official is authorized to administer and**
26 **expend the FY 2021 Planning and Economic Development Department**
27 **Administration Budget as amended, provided that any amendments or**
28 **modifications shall be submitted for prior approval by the Tohono O'odham**
29 **Legislative Council.**
