

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2021 Bureau of Indian Affairs Judicial Branch P.L. 93-638**  
**Budget Amendment No. 2)**

**RESOLUTION NO. 21-157**

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds  
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate  
3 these funds for the benefit of the nation and its members" provided that "[a]ll  
4 expenditures of these funds shall be pursuant to appropriations or budgets"  
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham  
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the FY 2021 Bureau of Indian Affairs Judicial Branch Budget under the P.L. 93-638  
8 Master Contract was approved by Resolution 20-249 in the amount of \$461,365.07  
9 and subsequently amended by Resolution No. 21-047 in the amount of  
10 \$423,400.09; and

11 **WHEREAS,** the attached Federal Financial Report indicates FY 2020 carry forward savings in  
12 the amount of \$283,862.17; and

13 **WHEREAS,** the Judicial Branch has prepared and submitted for review and approval its FY  
14 2021 Bureau of Indian Affairs ("BIA") Judicial Branch P.L. 93-638 Budget  
15 Amendment No. 2, which is incorporated by this reference and which will adjust  
16 operational, personnel and/or capital line items; and

17 **WHEREAS,** the FY 2021 Judicial Branch P.L. 93-638 Budget Amendment No. 2 will increase the  
18 FY 2021 BIA Judicial Branch P.L. 93-638 Budget's indirect cost charges by  
19 \$21,804.22 from \$36,212.09 to 58,016.31 and in turn increase the FY 2021 Judicial  
20 Branch P.L. 93-638 Budget by \$305,666.39 from \$423,400.09 to \$729,066.48; and

21 **WHEREAS,** the Judiciary and Budget and Finance Committees have reviewed the FY 2021 BIA  
22 Judicial Branch P.L. 93-638 Budget Amendment No. 2 and recommend its  
23 approval.

24 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
25 FY 2021 Bureau of Indian Affairs Judicial Branch P.L. 93-638 Budget Amendment  
26 No. 2 effective October 1, 2020, which includes a \$305,666.39 increase from  
27 \$423,400.09 to \$729,066.48.

28 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Chief Judge and  
29 any designated official is authorized to administer and expend the FY 2021  
30 Bureau of Indian Affairs Judicial Branch P.L. 93-638 Budget as amended,  
31 provided that any modifications or amendments shall be submitted for prior  
32 approval by the Tohono O'odham Legislative Council.


