

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Tohono O'odham Nation's 2021 Indian Housing Plan for Indian
Housing Block Grant Program American Rescue Plan Funding)

RESOLUTION NO. 21-161

1 **WHEREAS,** the Constitution of the Tohono O'odham Nation vests the Legislative Council with
2 the power to enact laws "to promote, protect and provide for public health, peace,
3 morals, education and general welfare of the Tohono O'odham Nation and its
4 members" (Constitution, Article VI, Section 1(c)(2)); and

5 **WHEREAS,** the Tohono O'odham Ki:Ki Association ("TOKA") is the Nation's tribally
6 designated housing entity in accordance with the Native American Housing
7 Assistance and Self-Determination Act of 1996, 25 U.S.C §4101, *et seq.*, P.L. 104-
8 330, 110 Stat. 4016 ("NAHASDA"); and

9 **WHEREAS,** to qualify for Indian Housing Block Grant Program American Rescue Plan
10 ("IHBG-ARP") funding, the NAHASDA requires submission of an annual Indian
11 Housing Plan ("IHP") by the Indian tribe or by the tribe's designated housing
12 entity (25 U.S.C §4112); and

13 **WHEREAS,** pursuant to Article IX of the Nation's TOKA Ordinance, 18 Tohono O'odham Code,
14 Chapter 1, the TOKA shall submit annually to the United States Department of
15 Housing and Urban Development's Southwest Area Office of Native American
16 Programs ("SWONAP") the Nation's Indian Housing Plan after review and
17 approval by Legislative Council resolution (TOKA Ordinance, Article IX, 1, a.,
18 <https://tolc-nsn.gov/docs/Title18Ch1.pdf>); and

19 **WHEREAS,** under the direction of the TOKA's executive director, the TOKA prepared and
20 submitted the Nation's 2021 Indian Housing Plan for the IHBG-ARP funding to
21 TOKA's Board of Directors for review and approval (TOKA Ordinance, Article IX, 1,
22 b., ii.); and

23 **WHEREAS,** after approving the Nation's 2021 Indian Housing Plan for IHBG-ARP funding by
24 Resolution No. 05-04-21, the TOKA's Board of Directors provided the IHP for
25 IHBG-ARP funding to the Legislative Housing Committee for review and approval
26 (TOKA Ordinance, Article IX, 1, b., iii.); and

27 **WHEREAS,** the Legislative Housing Committee recommends approval of the Nation's 2021
28 Indian Housing Plan for the IHBG-ARP funding.

29 **NOW, THEREFORE, BE IT RESOLVED** by the Tohono O'odham Legislative Council that it approves
30 the Nation's 2021 Indian Housing Plan for IHBG-ARP funding, provided that any
31 amendments are subject to Legislative Council review and approval.

BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that it authorizes the Nation's Chairperson to sign the certification authorizing submission by the TOKA of the Nation's 2021 Indian Housing Plan for the IHBG-ARP funding.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 14TH day of MAY, 2021 at a meeting at which a quorum was present with a vote of 2,961.9 FOR; -0- AGAINST; -0- NOT VOTING; and 213.8 [04] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(c)(2) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).
