

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending Resolution No. 19-097, "Approving the Monthly Age 18 Report for April 2019 of Tohono O'odham Eligible Minor Members and Authorizing Distribution of the Per Capita Payments and Interest Held in Trust on Their Behalf by Wells Fargo Bank" to Correct Names and/or Roll Numbers of Members)

RESOLUTION NO. 21-178

1 **WHEREAS,** the Constitution of the Tohono O'odham Nation vests the Tohono O'odham
2 Legislative Council with the power "to manage any funds within the exclusive
3 control of the Tohono O'odham Nation, including proceeds derived from lands
4 and resources of the Tohono O'odham Nation, and to appropriate these funds for
5 the benefit of the nation and its members" (Constitution, Article VI, Section
6 1(d)(2)); and

7 **WHEREAS,** on June 28, 1997, the Nation's voters approved Initiative No. IN-01-97, the
8 "O'odham Voice on Use of Gaming Revenues" (the "Initiative"), which authorizes
9 per capita payments to the Nation's members provided that sufficient gaming
10 revenues are available; and

11 **WHEREAS,** the Ordinance for the Regulation of Gaming Activities Within the Tohono
12 O'odham Nation ("Gaming Ordinance") was subsequently amended to authorize
13 per capita distribution payments in accordance with the Initiative (Legislative
14 Council Resolution No. 97-303); and

15 **WHEREAS,** the Trust Agreement with Principal Trust Company requires that a listing of all
16 minor beneficiaries turning 18 that month be presented to the Tohono O'odham
17 Legislative Council to obtain approval to distribute the trust funds to these
18 eligible minor members as they are no longer restricted beneficiaries; and

19 **WHEREAS,** the Tohono O'odham Legislative Council approved the minors identified on the
20 Monthly Age 18 Report for April 2019 who reached the age of 18 and are no longer
21 restricted from receiving their per capita payments in Resolution No. 19-097; and

22 **WHEREAS,** the Nation's Enrollment Office has identified incorrect names and/or roll
23 numbers for members on the Monthly Age 18 Report for April 2019; and

24 **WHEREAS** the Nation's Enrollment Office recommends that the names and/or roll numbers
25 of the members be amended on the Monthly Age 18 Report for April 2019.

26 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council amends
27 Resolution No. 19-097, "Approving the Monthly Age 18 Report for April 2019 of
28 Tohono O'odham Eligible Minor Members and Authorizing Distribution of the
29 Per Capita Payments and Interest Held in Trust on Their Behalf by Wells Fargo
30 Bank," to reflect the correct names and/or roll numbers of the members in
31 accordance with the attached Monthly Age 18 Report Amendment June 2021.



2 **Trust Company to commence payment to the non-restricted beneficiaries listed**
3 **on the Monthly Age 18 Report Amendment for June 2021 the distribution of trust**
4 **payments from Principal Trust Company to approved minors identified on the,**
5 **subject to the additional requirements of the trust agreement and written**
6 **confirmation of the beneficiary's current mailing address and other**
7 **information.**

8 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 14TH**
9 **day of JUNE, 2021 at a meeting at which a quorum was present with a vote of 3,218,0 FOR; -0-**
10 **AGAINST; -0- NOT VOTING; and -0- ABSENT, pursuant to the powers vested in the Council by**
11 **Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the**
12 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
13 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
14 **18, 1934 (48 Stat.984).**
