## RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL (Appointing Ida Norris to the Enrollment Committee)

RESOLUTION NO. 21-182

1	WHEREAS,	the Tohono O'odham Legislative Council is vested with the power to provide for,
2		appoint, or provide for the appointment of, and prescribe the duties and powers
3		of committees, boards, officers and agents" (Article VI, Section 1(b) of the
4		Constitution of the Tohono O'odham Nation); and
5	WHEREAS,	the Legislative Council has enacted and subsequently amended Ordinance No.
6		05-81, the "Enrollment Ordinance," which establishes an Enrollment Committee
7		to receive and review all membership applications for enrollment in the Tohono
8		O'odham Nation, among other duties and responsibilities; and
9	WHEREAS,	the Enrollment Ordinance provides that the Enrollment Committee "shall be
10		composed of five members of the Tohono O'odham Nation who are bilingual in
11		the O'odham and English languages" and whose members "shall be appointed by
12		the Chairman of the Nation, subject to the approval of the Tohono O'odham
13		Legislative Council" (14 T.O.C. Chapter 1, Article II, Section 1(A) and 1(B)); and
14	WHEREAS,	Committee members "shall be appointed for a five-year term, but shall continue
15		to serve until the member's successor is appointed. Vacancies shall be filled for
16		the unexpired term of that seat on the Committee and appointments shall be
17		staggered so that no more than two members' terms shall expire in the same
18		year." (14 T.O.C. Chapter 1, Article II, Section 1(C)); and
19	WHEREAS,	by Legislative Council Resolution No. 15-416, Ida Norris continues to serve on the
20		Enrollment Committee with a term that expired January 1, 2021; and
21	WHEREAS,	subject to the approval by the Legislative Council, Chairman Ned Norris, Jr. has
22		appointed Ida Norris to the Enrollment Committee for another term; and
23	WHEREAS,	if approved, Ida Norris would serve on the Enrollment Committee until January
24		1, 2026, provided that she would continue to serve until replaced by a successor
25		who is appointed in accordance with the Enrollment Ordinance.
26	NOW, THERE	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the
27		appointment of Ida Norris to the Enrollment Committee upon the effective date
28		of this resolution for a term to expire on January 1, 2026, provided that she shall
29		continue to serve until her successor has been appointed in accordance with the
30		Enrollment Ordinance.
