

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2021 Baboquivari District Administration Budget Amendment No. 2, FY 2021 Baboquivari District Choulic Community Budget Amendment No. 4, FY 2021 Baboquivari District South Komelic Community Budget Amendment No. 2, and FY 2021 Artesia-Little Tucson Building Project Budget Amendment No. 1)

RESOLUTION NO. 21-184

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham
2 Nation,

3 No district council shall expend district funds except pursuant to budgets
4 authorized under resolutions of the district council and approved by the
5 Tohono O'odham Council. The management of these funds shall be only by
6 a treasurer or other authorized officer of the district council who has
7 furnished a surety bond satisfactory to the treasurer of the Tohono
8 O'odham Nation, and all expenditures of these funds shall be by checks
9 signed by such treasurer or other authorized officer and the chairman or
10 vice chairman of the district council.

12 **WHEREAS,** the FY 2021 Baboquivari District Budgets in the amount of \$3,074,043.86 were
13 authorized by Baboquivari District Council Resolution No. 2020-B-75 and
14 approved by Legislative Council Resolution No. 20-315, and subsequently
15 amended by Legislative Council Resolution No. 21-025 in the amount of
16 \$3,942,345.77, Resolution No. 21-026 with no change in the budget amount,
17 Resolution No. 21-081 in the amount of \$4,107,828.14, and Resolution No. 21-111
18 in the amount of \$4,330,648.47; and

19 **WHEREAS,** by Baboquivari District Council Resolution Nos. 2021-B-49 and 2021-B-50, the
20 Baboquivari District has authorized and submitted for review and approval its FY
21 2021 Administration Budget Amendment No. 2 and FY 2021 Choulic Community
22 Budget Amendment No. 4, which are incorporated by these references and which
23 will adjust operational and/or personnel line items; and

24 **WHEREAS,** the FY 2021 Baboquivari District Administration Budget Amendment No. 2 and FY
25 2021 Baboquivari District Choulic Community Budget Amendment No. 4 will not
26 change the FY 2021 Administration and Choulic Community budget amounts; and

27 **WHEREAS,** by Baboquivari District Council Resolution Nos. 2021-B-32 and 2021-B-42, the
28 Baboquivari District has authorized and submitted for review and approval its FY
29 2021 South Komelic Community Budget Amendment No. 2 and FY 2021 Artesia-
30 Little Tucson Building Project Budget Amendment No. 1, which are incorporated

1 by these references and which will adjust operational and/or personnel line
2 items; and

3 **WHEREAS,** the FY 2021 Baboquivari District South Komelic Community Budget Amendment
4 No. 2 will increase the FY 2021 South Komelic Community Budget by \$398,064.38
5 from \$382,730.12 to \$780,794.50 that shall be funded by FY 2014, FY 2015, FY 2016,
6 FY 2017, and FY 2018 carry forward funds; and

7 **WHEREAS,** the FY 2021 Baboquivari District Artesia-Little Tucson Building Project Budget
8 Amendment No. 1 will not change the FY 2021 Artesia-Little Tucson Project Budget
9 amount of \$704,390.96; and

10 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2021 Baboquivari District
11 Administration Budget Amendment No. 2, FY 2021 Baboquivari District Choulic
12 Community Budget Amendment No. 4, FY 2021 Baboquivari District South
13 Komelic Community Budget Amendment No. 2, and FY 2021 Artesia-Little Tucson
14 Building Project Budget Amendment No. 1 and recommends approval.

15 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
16 FY 2021 Baboquivari District Budget amendments effective October 1, 2020, as
17 follows:

- 18 (1) FY 2021 Administration Budget Amendment No. 2, which does not change
19 the budget amount of \$938,463.14;
- 20 (2) FY 2021 Choulic Community Budget Amendment No. 4, which does not
21 change the budget amount of \$701,429.99;
- 22 (3) FY 2021 South Komelic Community Budget Amendment No. 2, which
23 includes a \$398,064.38 increase from \$382,730.12 to \$780,794.50 that shall
24 be funded by carry forward funds as follows:
25 FY 2014 carry forward funds in the amount of \$47,889.94;
26 FY 2015 carry forward funds in the amount of \$86,538.75;
27 FY 2016 carry forward funds in the amount of \$52,321.01;
28 FY 2017 carry forward funds in the amount of \$78,568.92; and
29 FY 2018 carry forward funds in the amount of \$132,745.76; and
- 30 (4) FY 2021 Baboquivari District Artesia-Little Tucson Building Project
31 Budget Amendment No. 1, which does not change the budget amount of
32 \$704,390.96.

1 **BE IT FURTHER RESOLVED** by the Tohono O'odham Legislative Council that the FY 2021
2 **Baboquivari District Budget is increased by \$398,064.38 from \$4,330,648.47 to**
3 **\$4,728,712.85.**

4 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the FY 2021
5 **Baboquivari District Budgets as amended shall be managed and expended in**
6 **accordance with Article IX, Section 7 of the Constitution of the Tohono O'odham**
7 **Nation and the Nation's laws, provided that any amendments or modifications**
8 **shall be authorized under District Council resolution and submitted for prior**
9 **approval by the Tohono O'odham Legislative Council.**

10 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 14TH**
11 **day of JUNE, 2021 at a meeting at which a quorum was present with a vote of 3,218.0 FOR; -0-**
12 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**
13 **Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
14 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
15 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934**
16 **(48 Stat.984).**
