

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2021 Department of Health and Human Services Division of Community Health HIV AIDS Program Budget Amendment No. 1)**

**RESOLUTION NO. 21-187**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**  
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**  
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**  
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**  
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2021 Department of Health and Human Services Division of Community**  
8 **Health HIV AIDS Program Budget in the amount of \$200,879.00 was approved by**  
9 **Resolution No. 20-252; and**

10 **WHEREAS, the Department of Health and Human Services has prepared and submitted for**  
11 **review and approval its FY 2021 Division of Community Health HIV AIDS Program**  
12 **Budget Amendment No. 1, which is incorporated by this reference and which will**  
13 **adjust the operational and/or personnel line items; and**

14 **WHEREAS, the FY 2021 Department of Health and Human Services Division of Community**  
15 **Health HIV AIDS Program Budget Amendment No. 1 will decrease the FY 2021**  
16 **Division of Community Health HIV AIDS Program Budget by \$3,018.20 from**  
17 **\$200,879.00 to \$197,860.80; and**

18 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**  
19 **reviewed the FY 2021 Department of Health and Human Services Division of**  
20 **Community Health HIV AIDS Program Budget Amendment No. 1 and recommend**  
21 **its approval.**

22 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
23 **FY 2021 Department of Health and Human Services Division of Community Health**  
24 **HIV AIDS Program Budget Amendment No. 1 effective October 1, 2020, which**  
25 **includes a \$3,018.20 decrease from \$200,879.00 to \$197,860.80 that shall be**  
26 **funded by carry forward funds from the Self-Governance Funding Agreement.**

27 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
28 **Nation chairperson or any designated official is authorized to administer and**  
29 **expend the FY 2021 Department of Health and Human Services Division of**  
30 **Community Health HIV AIDS Program Budget as amended, provided that any**  
31 **amendments or modifications shall be submitted for prior approval by the**  
32 **Tohono O'odham Legislative Council.**
