

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2021 Department of Health and Human Services Division of Community
Health Budget Amendment No. 1)**

RESOLUTION NO. 21-188

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2021 Department of Health and Human Services Division of Community**
8 **Health Budget in the amount of \$2,466,746.00 was approved by Resolution No. 20-**
9 **252; and**

10 **WHEREAS, the Department of Health and Human Services has prepared and submitted for**
11 **review and approval its FY 2021 Division of Community Health Budget**
12 **Amendment No. 1, which is incorporated by this reference and which will adjust**
13 **operational and/or personnel line items; and**

14 **WHEREAS, the FY 2021 Department of Health and Human Services Division of Community**
15 **Health Budget Amendment No. 1 will increase the FY 2021 Department of Health**
16 **and Human Services Division of Community Health Budget by \$815,913.01 from**
17 **\$2,466,746.00 to \$3,282,659.01; and**

18 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**
19 **reviewed the FY 2021 Department of Health and Human Services Division of**
20 **Community Health Budget Amendment No. 1 and recommend its approval.**

21 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
22 **FY 2021 Department of Health and Human Services Division of Community Health**
23 **Budget Amendment No. 1 effective October 1, 2020, which includes a \$815,913.01**
24 **increase from \$2,466,746.00 to \$3,282,659.01 that shall be funded by carry forward**
25 **funds from the Self-Governance Funding Agreement.**

26 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
27 **Nation chairperson or any designated official is authorized to administer and**
28 **expend the FY 2021 Department of Health and Human Services Division of**
29 **Community Health Budget as amended, provided that any amendments or**
30 **modifications shall be submitted for prior approval by the Tohono O'odham**
31 **Legislative Council.**
