

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2022 Department of Health and Human Services Division of Community
Health Services Public Health Preparedness Budget)**

RESOLUTION NO. 21-189

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Department of Health and Human Services has prepared and submitted for**
8 **review and approval its FY 2022 Division of Community Health Services Public**
9 **Health Preparedness Budget, which is incorporated by this reference, in the**
10 **amount of \$80,000.00 to be funded by the Arizona Department of Health Services;**
11 **and**

12 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**
13 **reviewed the FY 2022 Department of Health and Human Services Division of**
14 **Community Health Services Public Health Preparedness Budget and recommend**
15 **its approval.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
17 **FY 2022 Department of Health and Human Services Division of Community Health**
18 **Services Public Health Preparedness Budget effective July 1, 2021 in the amount**
19 **of \$80,000.00, which shall be funded by the Arizona Department of Health**
20 **Services.**

21 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
22 **Nation chairperson or any designated official is authorized to administer and**
23 **expend the FY 2022 Department of Health and Human Services Division of**
24 **Community Health Services Public Health Preparedness Budget, provided that**
25 **any amendments or modifications shall be submitted for prior approval by the**
26 **Tohono O'odham Legislative Council.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 15TH**
28 **day of JUNE, 2021 at a meeting at which a quorum was present with a vote of 3,218.0 FOR; -0-**
29 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**
30 **Article VI, Section 1(d) (2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**
31 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
32 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
33 **18, 1934 (48 Stat.984).**
