

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2021 Tohono O'odham Nation Health Care San Simon Outpatient  
Budget Amendment No. 1)**

**RESOLUTION NO. 21-191**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**  
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**  
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**  
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**  
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Tohono O'odham Nation Health Care ("TONHC") Governing Body was**  
8 **delegated the authority to review and approve all TONHC budgets and budgets**  
9 **expending health self-governance funds, including budgets expending such**  
10 **funds for supporting programs within other Nation's departments, subject to**  
11 **Legislative Council oversight committee review and final approval by Legislative**  
12 **Council resolution (Tohono O'odham Nation Health Care Governing Body Bylaws,**  
13 **Section 9403(A)); and**

14 **WHEREAS, the FY 2021 Tohono O'odham Nation Health Care Budgets and Department of**  
15 **Information and Technology-Third Party in the amount of \$134,478,610.36 was**  
16 **approved by Resolution No. 20-283; and**

17 **WHEREAS, the Tohono O'odham Nation Health Care has prepared and submitted for review**  
18 **and approval its FY 2021 Tohono O'odham Nation Health Care San Simon**  
19 **Outpatient Budget Amendment No. 1, which is incorporated by this reference and**  
20 **which will adjust operational and/or personnel line items; and**

21 **WHEREAS, the FY 2021 Tohono O'odham Nation Health Care San Simon Outpatient Budget**  
22 **Amendment No. 1 will not change the budget amount of \$840,092.61; and**

23 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**  
24 **reviewed the FY 2021 Tohono O'odham Nation Health Care San Simon Outpatient**  
25 **Budget Amendment No. 1 and recommend approval.**

26 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
27 **FY 2021 Tohono O'odham Nation Health Care San Simon Outpatient Budget**  
28 **Amendment No. 1 effective October 1, 2020, which does not change the budget**  
29 **amount of \$840,092.61.**

30 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
31 **Nation chairperson or any designated official is authorized to administer and**  
32 **expend the FY 2021 Tohono O'odham Nation Health Care San Simon Outpatient**




**Budget as amended, provided that any amendments or modifications shall be submitted for prior approval by the Tohono O'odham Legislative Council.**
