

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2021 Schuk Toak District Queens Well Community Budget  
Amendment No. 1)**

**RESOLUTION NO. 21-195**

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham  
2 Nation,

3 No district council shall expend district funds except pursuant to budgets  
4 authorized under resolutions of the district council and approved by the  
5 Tohono O'odham Council. The management of these funds shall be only  
6 by a treasurer or other authorized officer of the district council who has  
7 furnished a surety bond satisfactory to the treasurer of the Tohono  
8 O'odham Nation, and all expenditures of these funds shall be by checks  
9 signed by such treasurer or other authorized officer and the chairman or  
10 vice chairman of the district council.

12 **WHEREAS,** the FY 2021 Schuk Toak District Budget in the amount of \$3,074,043.86 was  
13 authorized by Schuk Toak District Council Resolution No. ST-08-12-20-052 and  
14 approved by Legislative Council Resolution No. 20-333 and subsequently  
15 amended by Legislative Council Resolution No. 21-021, Resolution No. 21-118, and  
16 Resolution No. 21-119 with no changes to the budget amount; and

17 **WHEREAS,** by Schuk Toak District Council Resolution No. ST-04-24-21-051, the Schuk Toak  
18 District has authorized and submitted for review and approval its FY 2021 Queens  
19 Well Community Budget Amendment No. 1, which is incorporated by this  
20 reference and which will adjust operational and/or personnel line items; and

21 **WHEREAS,** the FY 2021 Schuk Toak District Queens Well Community Budget Amendment No.  
22 1 will not change the FY 2021 Queens Well Community Budget amount of  
23 \$80,000.00; and

24 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2021 Schuk Toak District  
25 Queens Well Community Budget Amendment No. 1 and recommends its approval.


26 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
27 FY 2021 Schuk Toak District Queens Well Community Budget Amendment No. 1,  
28 effective October 1, 2020 which does not change the FY 2021 Queens Well  
29 Community Budget amount of \$80,000.00 nor the FY 2021 Schuk Toak District  
30 Budget amount of \$3,074,043.86.

31 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the FY 2021 Schuk  
32 Toak District Budget as amended shall be managed and expended in accordance  
33 with Article IX, Section 7 of the Constitution of the Tohono O'odham Nation and

the Nation's laws, provided that any amendments or modifications shall be authorized under District Council resolution and submitted for prior approval by the Tohono O'odham Legislative Council.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 16<sup>TH</sup> day of JUNE, 2021 at a meeting at which a quorum was present with a vote of 3,218.0 FOR; -0- AGAINST; -0- NOT VOTING; and -0- ABSENT, pursuant to the powers vested in the Council by Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).


