

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2021 Schuk Toak District Emergency Fund Budget)**

RESOLUTION NO. 21-196

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham
2 Nation,

3 No district council shall expend district funds except pursuant to budgets
4 authorized under resolutions of the district council and approved by the
5 Tohono O'odham Council. The management of these funds shall be only by
6 a treasurer or other authorized officer of the district council who has
7 furnished a surety bond satisfactory to the treasurer of the Tohono
8 O'odham Nation, and all expenditures of these funds shall be by checks
9 signed by such treasurer or other authorized officer and the chairman or
10 vice chairman of the district council.

12 **WHEREAS,** by Schuk Toak District Council Resolution No. ST-05-08-21-061, the Schuk Toak
13 District has authorized the FY 2021 Schuk Toak District Emergency Fund Budget,
14 which is incorporated by this reference in the amount of \$28,143.64 that will be
15 funded by the RBC Wealth Management Investment Account Emergency Fund;
16 and

17 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2021 Schuk Toak District
18 Emergency Fund Budget and recommends its approval.

19 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
20 FY 2021 Schuk Toak District Emergency Fund Budget effective October 1, 2020 in
21 the amount of \$28,143.64, which shall be funded by RBC Wealth Management
22 Investment Account Emergency Fund.

23 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the FY 2021 Schuk
24 Toak District Emergency Fund Budget shall be managed and expended in
25 accordance with Article IX, Section 7 of the Constitution of the Tohono O'odham
26 Nation and the Nation's laws, provided that any amendments or modifications
27 shall be authorized under District Council resolution and submitted for prior
28 approval by the Tohono O'odham Legislative Council.

29 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 16TH**
30 **day of JUNE, 2021 at a meeting at which a quorum was present with a vote of 3,218.0 FOR; -0-**
31 **AGAINST; -0- NOT VOTING; and -0- ABSENT, pursuant to the powers vested in the Council by**
32 **Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
33 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
34 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934**


