

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2022 Department of Health and Human Services Senior Services  
Program Title III Budgets)**

**RESOLUTION NO. 21-201**

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds  
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate  
3 these funds for the benefit of the nation and its members" provided that "[a]ll  
4 expenditures of these funds shall be pursuant to appropriations or budgets"  
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham  
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the Department of Health and Human Services has prepared and submitted for  
8 review and approval its FY 2022 Senior Services Program Title III Budgets, which  
9 are incorporated by these references (collectively, "FY 2022 Title III Budgets"):

16 **WHEREAS,** the Health and Human Services and Budget and Finance Committees have  
17 reviewed the FY 2022 Department of Health and Human Services Senior Services  
18 Program Title III Budgets and recommend their approval.

19 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
20 FY 2022 Department of Health and Human Services Senior Services Program Title  
21 III Budgets effective July 1, 2021-June 30, 2022 in the amount of \$116,033.00, which  
22 shall be funded by the Nation's general fund pending reimbursement by the  
23 grantor, Title III of the Older Americans Act through the Inter-Tribal Council of  
24 Arizona.

25 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham  
26 Nation chairperson or any designated official is authorized to administer and  
27 expend the FY 2022 Department of Health and Human Services Senior Services  
28 Program Title III Budgets, provided that any amendments or modifications shall  
29 be submitted for prior approval by the Tohono O'odham Legislative Council.
